

# **COVID-19 DHS Provider Meeting April 27, 2020**

#### General Information

As of the time of this meeting (4-27-2020 at 4:30 pm) there are 1,224 confirmed cases and 79 deaths in the County.

- The new CMU maps, using information from FB and Google, are getting a lot of attention.
- The Health Department's dashboard provides additional information.
- The Hospital Association of Pennsylvania's <u>dashboard</u> shows information such as bed utilization.

# Supporting Youth

- The Youth Support Partner (YSP) Unit wants to make sure our youth continue to feel engaged, supported and connected during this time.
  - o They are engaging with youth through digital platforms, online gaming and streaming.
  - They are focusing on educating youth about physical fitness from home, budgeting and financial planning, learning new hobbies and life skills, virtual sightseeing, COVD-19 and PPE.
- 412 Youth Zone is also virtually assisting clients with:
  - o Accessing food and hygiene products, connecting to housing supports, ensuring safety
  - o Mental and physical health through telehealth, phone and text
  - Virtual programming including Virtual Book Club, News You Can Use, check-ins,
    STEAM projects, Music Mix, New Foods Friday and Art with Rachel. We are still able to offer a stipend for participating.

# Laptop Requests for DHS Clients

As a reminder, DHS is providing laptops for clients who need them to access visits with caseworkers, visits with family, tele-health, tele-therapy or school/learning. To request a laptop for a client:

- 1. Requestor fills out this form: https://bit.ly/DHSCOVID19Form.
- 2. DHS validates client information and need.
- 3. DHS contacts requestor to arrange for pick-up at HSB or to make other arrangements.

There are supply issues, but we are working with partners to provide as many as possible.

We are also thinking about ways to expand internet access.

We are hoping to launch the recruitment platform for temporary essential human service workers as early as Wednesday, 4-29-2020.

# Legislative/Policy Updates

State and local updates

• PA State legislature is in the early stages of budget planning for the 2020-2021 fiscal year.

- Discussing passage of a short-term budget by the end of May to run through October 31<sup>st</sup>
  this is reliant upon a line of credit to make up any tax revenue shortfalls.
- o If state revenue looks more normal by the end of October, the idea is to pass a "normal" budget for the remainder of the fiscal year, 11-1-2020 through 6-30-2021.
- PA has received \$2.5 billion from the Coronavirus Relief Fund established by the CARES Act for pandemic-related expenses.
  - Allegheny County is engaged in the process to receive an separate allocation from the Fund that is set aside for counties with populations over 500k.
- Allegheny County elections apply online or by mail to receive a mail-in ballot.

#### Food

<u>USDA shared some information</u> about a Food Box Distribution Program with the goal of getting fresh food to non-profits that can receive, store and distribute food. We are still keeping a close eye on this and will share additional details as we receive them. There was an RFP released, but it was for food suppliers, not non-profits.

  - Safe Haven Hotel
    - About 50 individuals are currently housed. Some people are beginning to return home.
    - Referral process update
      - We are enhancing medical screening by phone to make sure that patients are being put on the correct floor of the hotel.
      - Once accepted, individuals will also receive a quick phone call to discuss expectations and guidelines prior to moving to the hotel.

- As a reminder, referrals are now accepted from homelessness shelters, street outreach providers, and refugee and immigrant services. Any system with an individual in urgent need of safe haven, should reach out to your DHS contact.
