

COVID-19 DHS Provider Meeting July 23, 2020

General Information

COVID-19 Guidance Update

On July 17th, ACHD announced new guidance that takes state level guidance into account and remains in effect until revoked.

- Indoor and outdoor dining/alcohol consumption must end by 11 PM. Take-out and delivery for food/alcohol can continue after 11 PM. (State guidance makes it clear the number of indoor diners cannot exceed 25% of the fire code maximum.)
- Events/gatherings are limited to 25 people indoors/50 people outdoors. (State guidance allows 250 outdoors, but ACHD kept a lower limit.)

PA DCED published a new <u>Hazard Pay Grant Program:</u>

- Funds may be used to provide hazard pay for direct, full-time and part-time employees earning less than \$20 per hour, excluding fringe benefits and overtime.
- Provides 10 weeks of increased pay and up to \$1,200 per eligible full-time equivalent (FTE), for up to 500 eligible FTEs, or \$600,000, per location.
- Eligible providers include residential care facilities and healthcare and social assistance agencies.

COVID-19 Metrics

Allegheny County is not meeting the following benchmarks:

- Decline in new cases: we saw 941 new cases the week of 7/11, but we seem to be going in the right direction.
- New cases below threshold: our rate is 209 per 100,000 residents, above 50, but we seem to be going in the right direction.
- Diagnostic testing capacity: Our tests-to-cases ratio is remaining flat at 11:1.
- New cases below threshold: We are above the PA threshold of 50, at 209.
- Percent of positive tests: It is now 10.2% and increasing.

Allegheny County has an unknown status regarding the following benchmarks:

- ICU bed capacity: HACP data are no longer being published.
- Decline in total hospitalizations: HACP data are no longer being published but we know anecdotally that hospitalizations are increasing.

Allegheny County is meeting the following benchmarks:

• Decline in deaths: There were 3 deaths last week, a decrease. But, this is a lagging indicator behind cases and hospitalizations.

• Rate of transmission below 1: It was 0.93 during the week of 7/14.

Scott Hemphill, Chief Information Officer at DHS, joined the call to speak about DHS's efforts to bridge the digital divide.

The Digital Divide in Allegheny County

- 9% of households do not have an internet enabled device and 7% of households only have a smartphone, which is not sufficient for tasks such as conducting work or completing schoolwork.
- 13% of households do not have internet access; 40% of those households had an income of less than \$20,000 per year.

DHS is working to address the digital divide through:

- 1. Access to devices
 - a. 625 devices distributed out of 780 purchased or donated.
 - b. As a reminder, you can request a laptop through this form.
- 2. Access to wi-fi
 - a. We are covering the Mon Valley Regional Office parking lot with free public wi-fi.
 - i. However, a parking lot is not an ideal space for those without a car, looking to complete schoolwork or looking for privacy.
 - ii. We have identified about 30 potential additional locations.
 - b. We are talking to Comcast Internet Essentials about buying in-home internet connectivity for 2400 households.
 - c. We are also looking at Verizon jetpacks (portable hotspots) and LTE enabled devices, but these are more expensive options.
 - d. We are also developing a community wi-fi resource map to identify other public hotspots and local businesses offering wi-fi.
- 3. Enhancing digital literacy
 - a. Assisting providers with online delivery & virtual programming
 - b. Directing tech support to Pitt's Community Tech Help Desk

In a live survey, attendees shared the following feedback on DHS's efforts to Bridge the Digital Divide:

- 48 out of 56 respondents find in-home internet access more valuable than public hotspots.
- Family Centers, Senior Centers and public parks were seen as high value sites for a public hotspot.
- Respondents rated their comfort with technology as 4.13 out of 5.
- 19 respondents desired additional technology support from DHS in implementing virtual services.

Legislative/Policy Updates

Federal Updates

- U.S. Senate is expected to unveil a \$1 trillion relief package soon, formalizing the starting point of negotiations for the next bill.
 - We'll continue to track and report on details as they are available.

State and Local Updates

- VoteSafe Pennsylvania has launched a statewide bipartisan campaign to ensure safe voting options for the November election.
 - The coalition is led by former PA Republican House Majority Leader Dave Reed and former Democratic U.S. Rep. Patrick Murphy.
- Pittsburgh City Council is considering a proposal from the Mayor's Office to utilize Allegheny
 County Department of Health grant funding on an arrest diversion pilot program on the North
 Side, focusing on improving outcomes for justice-related individuals with behavioral health
 needs
- Pittsburgh Food Policy Council and PghFoodTeam received a \$100,000 grant from the Aetna Foundation to reduce disparities in chronic disease outcomes through change to food access systems.
 - PghFoodTeam includes Pittsburgh Food Policy Council, ACHD and the City of Pittsburgh as well as community organizations..
