

New Order (7/8/20)

- Health Department Director Dr. Bogen issued a new **two-week [order](#) that takes effect at 12:01 a.m. on Friday, July 10, 2020.**
- The new order rescinds the June 28 and July 2 orders.
- Bars, restaurants or any other business establishment with food service are permitted to provide take-out and delivery sales, of food and alcohol, as well as dine-in service in outdoor seating areas as long as the establishment adheres to the State's [Guidance](#).
- Events and gatherings of more than 25 persons indoors and more than 50 persons outdoors in Allegheny County are prohibited.
 - The requirement does not apply to religious gatherings held by churches, synagogues, temples, mosques, or other places of worship.

Metric 1: Decline in new cases

Current Status is Red: Allegheny County saw a 54% increase in new cases in the last week, following a 400% increase the previous week. The most recent week (6/28-7/4) had the highest number of new cases in a single week since the start of the pandemic.


Metric #1—Decline in New Cases or low number of new cases. States, including North Dakota, Kansas, and North Carolina, are looking for a downward trajectory of new cases over a 14-day period to monitor infection spread. Allegheny County is monitoring this as well as monitoring for any large increases in new cases.

Metric Definition: A decline in new cases over the course of a 14-day period and/or continued low number of new cases.

Metric#2 New cases below threshold

Current Status is Red: Allegheny County had new positive cases per 100,000 residents above 50 over the last 14 days for the first time since the start of the pandemic. The daily average increased by almost 200% each week for the last 2 weeks.




Metric #2—New rate of cases below threshold. The PA Department of Health, in coordination with other stakeholders, developed criteria to guide decisions about reopening that includes sustained positive cases below 50 per 100,000 residents. Metric definition: The new positive cases per 100,000 residents is below 50 over the last 14 days.

Metric #7: Percent positive tests

Current Status is **Yellow**:

On July 4th, 10% (55 of 486) of tests were positive. The average rate of positivity has increased in the last two weeks and has been over 10% twice in the last week.



Metric #8— Percent positive cases. According to the World Health Organization, communities that see about 10% or fewer positives among their test results may be testing enough. If the rate is higher, they are likely missing a lot of active infections.

Metric definition: Percent of positive tests is 10% or less.

Metric #6: Diagnostic Testing Capacity

Current Status is Red:

The ratio of testing to cases was 10 over the last week, which was a 18% decrease from the previous week and is below the recommendation of 50. Though overall testing continues to rise, it is not keeping pace with the increase in the number of cases.



Metric #6—Diagnostic Testing Capacity. A high level of testing is necessary to identify most people who are infected and isolate them from people who are healthy.

Metric definition: Total diagnostic tests divided by total cases over the last 7 days must equal or exceed 50.

Data source: Washington State Department of Health

NOTE: Per the Health Department, there is a data lag of 3-5 days in reported tests and cases. Data through July 4, 2020 was used for this metric.



Metric #3 Decline in Hospitalizations

Current Status is **Red**:

There has been an increase in the number of people in the hospital since June 17th and a 78% increase in average daily number of people in the hospital in the last week.


Metric #3—Decline in Total Hospitalizations. The Centers for Disease Control and Prevention (CDC) recommends that reopening be dependent on a downward trajectory of hospitalizations and infections over a 14-day period.

Metric Definition: A decline in the three-day rolling average of total net hospitalizations (defined as the total number of people in the hospital on a given day) over the course of a 14-day period.

Metric #5: ICU Bed Usage

Current Status is Green:

Pennsylvania states that ICU capacity should not exceed 90%. Allegheny County remains below that threshold and capacity has been steady in the upper 70% or the last 4 weeks.



Metric #5—ICU Bed Use. Nearly 30% of hospitalizations for COVID-19 ultimately require critical care. Regional health care systems should both maintain sufficient bed capacity for a potential resurgence in cases and have specific ICU bed capacity. Metric definition: Percent of ICU beds that are currently occupied is less than 90%

Metric#4: Decline in Deaths

Current Status is Green:

The 3-day average of daily deaths in Allegheny County per day has never exceeded 5 and declined in the last week. However, this is a lagging indicator, so may increase in the coming weeks.


Metric #4—Decline in Deaths. The number of daily deaths is another metric for monitoring the infection rate.

Metric 8: Reproduction number of COVID-19 below 1

Current Status is **Red**:

On July 5th, the R_0 value in Allegheny County was 1.9. Though still above 1, the average value decreased by 22% in the last week.


If R_0 is less than 1, each existing infection causes less than one new infection. In this case, the disease will decline and eventually die out.








Provider – Staff and Client Illness



Provider - Status of Reports on Infection for Clients and Staff





Policy & Legislative Update – Local

- On Tuesday, Allegheny County Council approved and passed the Coronavirus Relief Fund (CRF) appropriations established by the federal CARES Act. This approved COVID-19 related funding can now be distributed to County Departments and municipalities.
- Pittsburgh City Council held a public hearing on possible changes to the Citizen's Police Review Board's powers, including requiring full cooperation from any officer being investigated.
 - Any changes could only be approved through a City-wide referendum since the CPRB is a part of the City's Home Rule Charter.

Safeguarding people at risk, helping those facing hardship

Plan for Covid-19 response
Allegheny County DHS

The reasons for the plan

Our clients have higher risk of getting seriously ill from Covid

- People with chronic conditions are at much greater risk of serious illness or death from Covid
- DHS clients—chronic condition rates
 - Mental health residential clients: 48%
 - People with intellectual disabilities: 47%
 - Older adults (not in nursing homes): 46%
 - People experiencing homelessness and other housing insecurity: 40%
 - Parents involved with child welfare: 43%

Especially concerned about:

People in congregate living

Shelters: study found 25% positive for Covid

In Allegheny County DHS' programs, 94 of 130 positives lived or worked in congregate setting

Older adults

Over 60% of PA deaths were in long-term facilities, personal care homes

Older adults living at home contract virus from loved ones, staff who come into their home

More hardship for more people in the county

- Unemployment (16.8% in PSMA in June), reduction in hours will increase need in 2020-21
 - Households earning under \$40,000 hit hardest: 65% lost wages vs. 41% for HH earning >\$75,000
- Housing
 - One in five renters not able to pay rent in August
 - Rent, utility assistance calls to 211 up over same quarter of 2019 (43% of all calls in May)
- Mental health/substance use
 - National survey: 36% say Covid has serious impact on MH; 8% reported increase in alcohol/other drugs
 - Symptoms of serious psychological distress highest among young adults, adults with household income of less than \$35,000 per year, and Hispanic adults
 - 17% of Pittsburgh residents surveyed in June felt depressed, 14% hopeless about the future
- Children
 - Abuse and neglect increases correlated with unemployment
 - Number who are hungry in Allegheny County estimated to increase 58%
 - 23% of children in County estimated to be food insecure (already)

All of this affects black people more

All of this affects black people more

- Black nursing home residents are more likely to live in a facility with disease Covid cases than white people (national studies)
- Comorbidity:
 - Hypertension is prevalent among 40% of non-Hispanic Blacks compared with 28% of whites and Hispanics.
 - Non-elderly Blacks and native populations are twice as likely as whites to have had a heart attack or heart disease
- Allegheny is one of five PA counties whose black unemployment claims rate exceeds the white rate by 5 percentage points

CARES Funding

- Coronavirus Relief Fund: \$212M to Allegheny County
 - \$38 M to DHS, including funding for Food initiative (United Way); and Child Care (Trying Together)
- CSBG: \$1.7M thru 2022
 - DHS will address emerging needs of low-income households impacted by COVID-19, including work to expand its “self-sufficiency” programs; implement a new workforce initiative; and sustain the public benefits enrollment begun with CRF funds.
- Aging: \$500K this SFY; \$3.7M pending for next SFY
 - DHS will provide home delivered meals, congregate meals, support services, and caregiver services.
- Title IV-B: \$186K thru 2021
 - DHS will utilize these funds for CYF expenses incurred after January 2021, to minimize impact of expected Needs-Based budget cuts.
- ECE Supplemental: \$4.7M thru June 2020
 - DHS passes these funds through to Trying Together and the Alliance for Infants and Toddlers. Funds for child care providers to remain open or reopen, and for reducing child care subsidy wait list.
- Head Start COVID Response & Supplemental Summer Programs: \$850K pending
 - DHS passes these funds through to Allegheny Intermediate Unit. Funds will support COVID-related costs and the delivery of summer programming to Head Start children to offset learning losses from program closures.



Seniors and the Heat: Staying Cool

Food: Farmers Market Vouchers

- Unlike previous years where vouchers were picked up at Allegheny County Senior Centers just on one day, Vouchers are now being sent by US Mail.
- First mailings occurred this week.
 - Our target is to have all Vouchers mailed out within the next two weeks.
 - This target period is so we hit the height of the growing season and the most popular fresh foods are available.
- More than 12,000 application have been received.
- More than half a million dollars in Voucher are being mailed.
- There is no waiting list for Vouchers currently.



SCHOOL BUS STOP MEAL PICK UP IN PENN HILLS

Starting July 1st - 11:00-1:00

Every Monday, Wednesday & Friday

Through a collaborative partnership spanning government, nonprofit, and local business, food delivery bus routes have been developed throughout the Penn Hills community to ensure children, families, and seniors can receive meals at convenient locations during this difficult and uncertain time. Partners include the United Way of Southwestern PA, Eat'n Park, A Second Chance Inc, Carnegie Mellon University, Allegheny County Department of Human Services, Penn Hills School District, Greater Pittsburgh Community Food Bank, the Municipality of Penn Hills, Allies for Children, Penn Hills Clergy Association, and other community organizations. Generously funded through the United Way's Students and Families Food Relief Fund, this model has the capacity to serve an additional 1,000 meals per day.

Beginning on July 1st, ACCESS vehicles will deliver food to Penn Hills residents along five bus routes. The stops are strategically placed to ensure residents are able to access the food they need. Communications alerting residents to the bus routes will be conducted through community organizations, municipal channels, and the school district. By launching this model, Penn Hills is leading the way for other communities, as this innovation is now being replicated in additional municipalities with significant need. The United Way's Students and Families Food Relief Fund has already served over 250,000 meals since the end of March. With this newfound collaboration and innovative delivery model, capacity to feed more families is expected to grow.



Governor Wolf signed a new [executive order](#) that protects homeowners and renters from eviction or foreclosure until Aug. 31, if they have not received assistance from the new CARES Act Rental Assistance Program or are not already receiving relief through one of several federal foreclosure moratorium programs or judicial orders.




PHFA's CARES Rent Relief Program

- Applications are now available (applications can be submitted starting July 6th) for people seeking rent or mortgage relief due to COVID-19.
- To be eligible, renters and homeowners must:
 - document at least a 30% reduction in annual income since March 1 related to COVID-19, or they must have become unemployed after March 1;
 - household income must be under 100% of area median income

Get help paying rent during COVID-19

Governor Wolf allocated \$150 million of federal funding to help struggling Pennsylvanians avoid eviction. The Pennsylvania Housing and Finance Agency (PHFA) is administering the CARES Rent Relief Program (CRRP) on behalf of the state and Allegheny County Economic Development and the Department of Human Services is managing it locally.

Who qualifies for CARES rental assistance?

- ✓ Renter's income may not exceed the [Area Median Income](#) for their county of residence (and adjusted for the number of people in the household).
- ✓ Renter must document at least a 30% reduction in income since March 1, 2020, due to COVID-19, **or**
- ✓ Renter must have become **unemployed** as verified by the PA Department of Labor and Industry, after March 1, 2020 as a result of COVID-19

How much assistance can a renter get?

- ✓ Through PHFA funding, the maximum amount available per renter is \$750 a month, covering no more than six (6) months of rent expenses. The maximum funding available per renter is \$4,500.
- ✓ With Allegheny County supplemental funding, the maximum amount available per renter is an
