# Update on CARES (CRF) spending

- Reminder to submit all invoices by October 13<sup>th</sup> for the months of July, August and September
- Continue to bill within the first 10 business days of November and December.
- Submit final invoices by January 5, 202.1
- CRF expenditures must be incurred by 12/30/20.

- Hotspots are available now! Distributions are held most Fridays.
- Laptops can still be requested but remain out of stock. Our next shipment is expected mid-October.

Julie DeSeyn from United Way joined the call to share about 2-1-1, a 24-hour service that connects individuals and families to resources that can assist with human service needs.

- Calls are free, anonymous and confidential.
- People are mostly calling about basic needs: Food, utilities and housing. United Way can share the call data with you if needed.
- 2-1-1 has multi-lingual resource navigators & access to language line (over 250 languages)

# Legislative/Policy Updates

### Federal Updates

- Congress is close to passing a Continuing Resolution (CR) to fund the government thru mid-December.
  - o Includes funding to continue the Pandemic EBT (P-EBT) food program.
  - o Excludes new stimulus funding for local and state governments.
  - o Supreme Court vacancy battle overshadowing the chance of an independent stimulus bill.

#### State and Local Updates

- Pennsylvania launched new virus exposure notification phone app, COVID Alert PA. <u>Link</u> to Governor's Office press release.
- Full PA Senate will consider COVID-19 funding-related bills week of October 5th, including a bill creating the Nonprofit Economic Emergency Delivery Systems Grants Program with a \$200m appropriation.
- The County Health Department has lifted the County-specific order. The local order was more restrictive on the size of outdoor gatherings than the statewide limit.
- <u>State orders</u> on mask-wearing, mandatory telework, worker safety, building safety and hospital safety all remain in place.

- Additionally, business occupancy restrictions applicable to personal care service, indoor recreation and health and wellness facilities, entertainment venues, and bars and restaurants are also in effect.
- Pittsburgh City Council passed a bill outlawing City purchase and use of facial recognition technology for Pittsburgh Police.

# **Program Updates**

#### <u>OCS</u>

- Housing
  - o Allegheny County CARES Rent Relief Program Update
    - Allegheny County is partnering with the Pennsylvania Housing Finance Agency (PHFA) to jointly fund the CARES Rent Relief Program.
    - To date, we have received 5,536 tenant (unduplicated) applications and 2,791 landlord applications. The program requires an application from both parties to move forward.
      - Most applications were sent in without any supporting documentation.
        We are reaching out to these applicants to help them collect the needed docs.
      - Most applications did not have an accompanying landlord application.
        We are reaching out to landlords to get the needed documentation. Some landlords are refusing.
      - We faced additional challenges such as a very fast start up, a small application window and eligibility (the arrears must be caused by COVID).
    - We have paid a total of 190 applications. 109 were paid through the original CRRP program, and 81 more through a county-only addendum program that accepts people who don't meet all of the states CRRP documentation standards.
    - The State recently lowered the documentation requirements for CRRP and we are hopeful that they may increase the application deadline into October.
    - If your clients are not eligible for this program, you can refer them to:

- The Allegheny Link (1-866-730-2368) to be screened and referred for Eviction Prevention assistance
- 2-1-1 for referrals to the URA's Housing Opportunity Fund (city residents only)
- o Congregate setting guidance: please review the guidance
  - Public contact allow clients to stay inside as much as possible
  - Meals avoid congregate meals
  - Distancing continue physical distancing
  - Masks Ensure staff and as many clients as possible are wearing masks
  - Symptom checks Conduct temperature and symptom checks for staff and clients – staff should stay home if they feel ill in any way
  - Cleaning Maintain cleaning schedule and request cleaning services through form if necessary

# **CYF**

- Foster Care Redesign
  - We need more foster homes and we are facing high turnover of non-kin homes.
  - Our vision:
    - Targeted recruitment
      - Diverse array of available homes
      - Enable children to stay in their neighborhood
      - Allow siblings to stay together
    - Loving homes with foster care families who practice cultural humility and cultivate relationships with birth families
    - A network of peer support for foster care families that includes foster care parents who live nearby and can provide advice, resources and respite care when needed

- Aftercare for children
- Providers and foster homes are fairly reimbursed and have the resources they need to ensure a successful placement and aftercare services
- Within each region, some of the homes are therapeutic foster care homes and every foster care home is trained in trauma-informed care
- Stronger partnerships between CYF and provider agencies
- o Released the Foster Care Concept Paper in July with our vision and ideas
  - Received 20+ Foster Care Public Comments
  - Here's what we heard:
    - Accountability measures should be tied to incentives
    - Need to recognize some things are out of providers' control; CYF and other players (e.g., Courts) should make relevant changes that support providers' work
    - More access to County data and less duplicative data entry for providers
    - Concerns about CYF lack of communication and support of providers and foster parents
    - Need to reassess the language used about the expectation for foster & birth family communication within 24-hour timeframe
    - Concerns about the "one size fits all" model for family support (Mockingbird Model) - suggestions to explore other models and current provider practice
    - Concerns about an expedited certification process
- Reviewing and incorporating feedback into an RFP—where we "re-procure" provider agencies
  - Winter 2020 release
