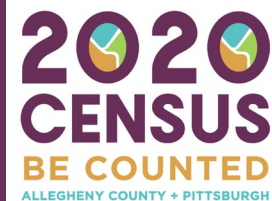

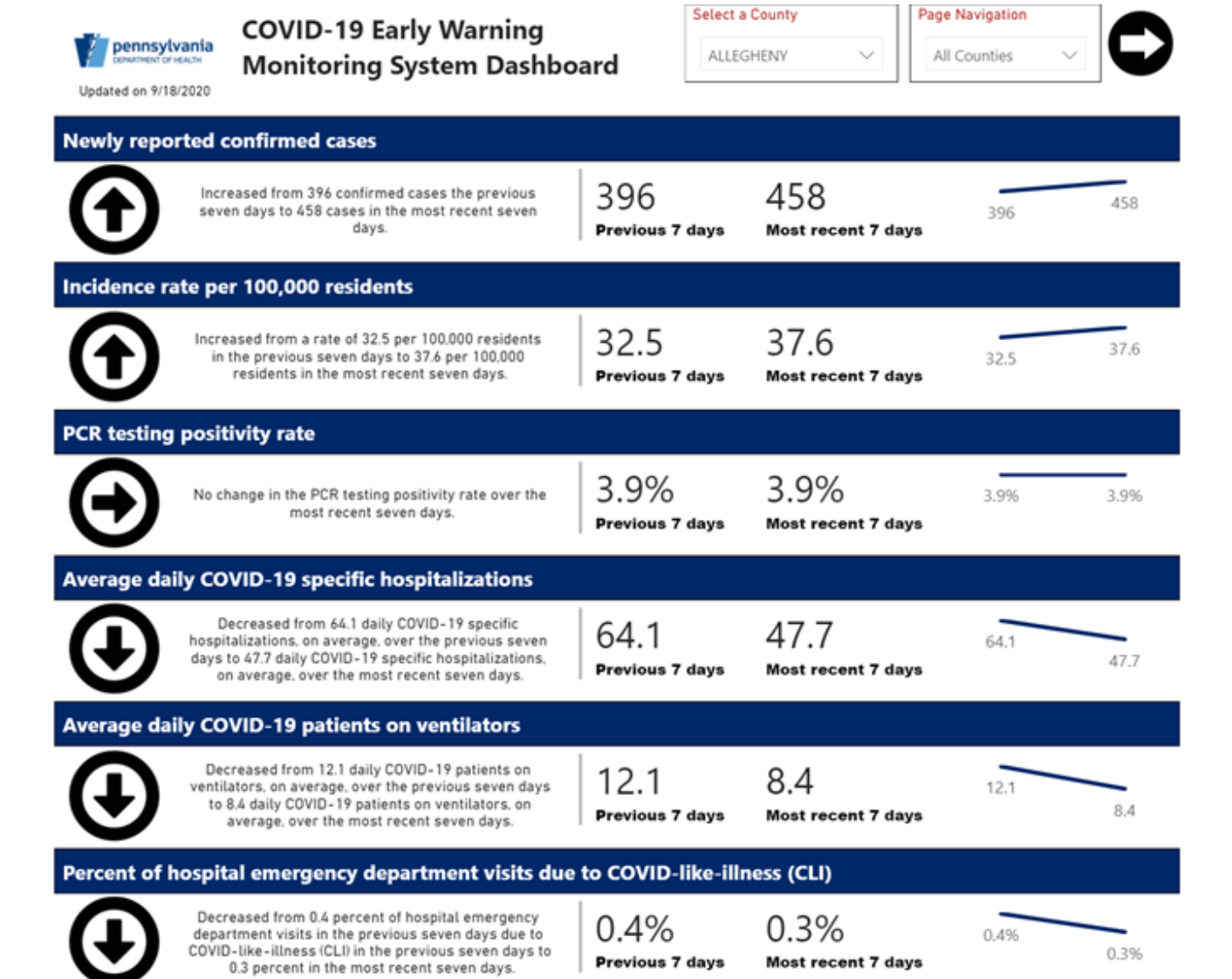

Health Metrics

- Compares this week (September 11th - September 17th) to previous week (September 3rd - September 10th). Data is updated every Friday.
- Both newly reported cases increased and the incidence rate per 100,000 residents increased by 16% over the last week. All other metrics are decreasing or remain the same as last week.



Active Solicitations

- RFP for Inpatient Program for Victims of Childhood Sex Trafficking
 - Renamed in response to community feedback (formerly called “RFP for Inpatient Program for Victims of Commercial Sexual Exploitation of Children”)
 - Proposals Due ~~September 30~~ October 14
 - RFP was amended on 9/14! Budget cap removed and deadline extended
 - See end of Q&A document for full details on all amendments

Policy & Legislative Update – Federal & State

- Congress is close to passing a Continuing Resolution (CR) to fund the government thru mid-December.
 - Includes funding to continue the Pandemic EBT (P-EBT) food program.
 - Excludes new stimulus funding for local and state governments.
 - Supreme Court vacancy battle overshadowing the chance of an independent stimulus bill.
- Pennsylvania launched new virus exposure notification phone app, COVID Alert PA. [Link](#) to Governor's Office press release.



Policy & Legislative Update – State & Local

- Full PA Senate will consider COVID-19 funding-related bills week of October 5th, including bill creating the Nonprofit Economic Emergency Delivery Systems Grants Program with a \$200m appropriation.
- The County Health Department has lifted the County-specific order. The local order was more restrictive on the size of outdoor gatherings than the statewide limit.
 - [State orders](#) on mask-wearing, mandatory telework, worker safety, building safety and hospital safety all remain in place.
 - Additionally, business occupancy restrictions applicable to personal care service, indoor recreation and health and wellness facilities, entertainment venues, and bars and restaurants are also in effect.
- Pittsburgh City Council passed a bill outlawing City purchase and use of facial recognition technology for Pittsburgh Police

CARES Coronavirus Relief Fund

- ▶ Thank You for the extra effort to execute CRF contracts timely
- ▶ Reminder to submit all invoices by October 13 for the months of July, August, and September
- ▶ Continue to bill within the first 10 business days of November and December
- ▶ Submit final invoices by January 5, 2021
- ▶ CRF expenditures must be incurred by 12/30/20

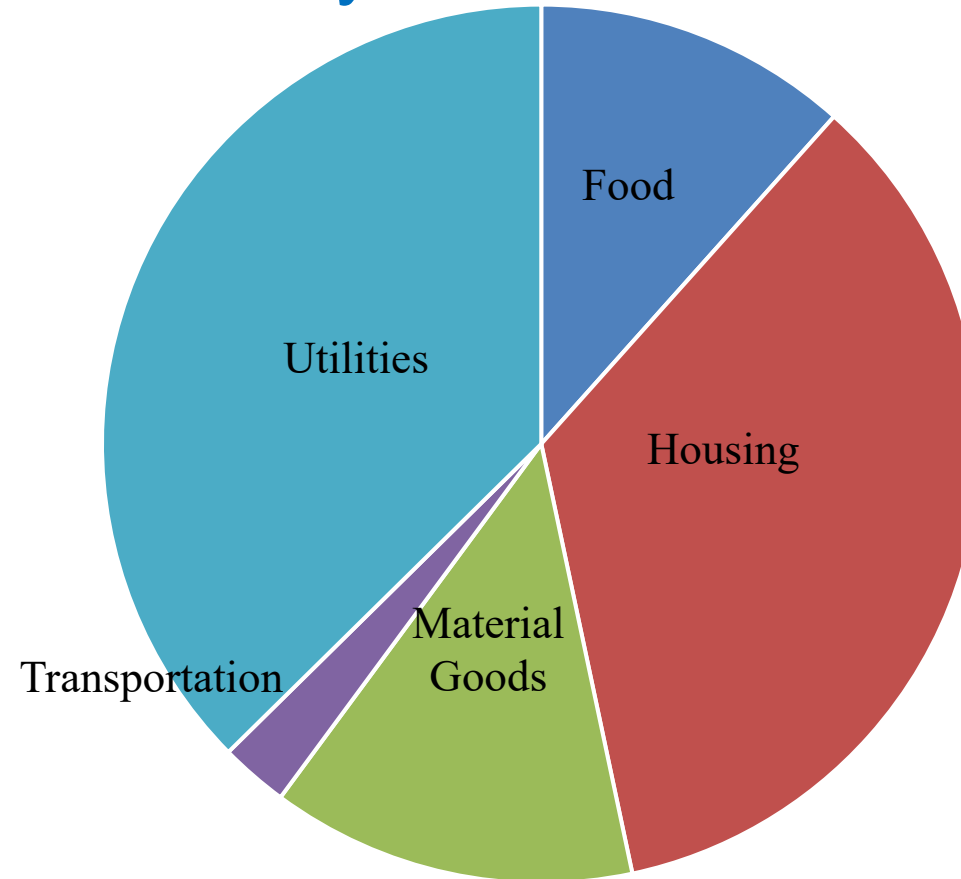

Allegheny County CARES Rent Relief Program (CRRP)

Allegheny County is partnering with the Pennsylvania Housing Finance Agency (PHFA) to jointly fund the CARES Rent Relief Program. CARES helps people experiencing job loss or loss of income as a result of the COVID-19

- Allegheny Co can access up to approx. \$22 million from the State
- County decided to cover rents above State level plus cover Utility Arrears (\$14 million)

Eligibility

- Renter's income may not exceed the [Area Median Income for Allegheny County](#) (and adjusted for the number of people in the household).
- Renter must document [at least a 30% reduction in income](#) since March 1, 2020, due to COVID-19; **OR**
- Renter must have become [unemployed](#), as verified by the PA Department of Labor and Industry, after March 1, 2020 as a result of COVID-19

What assistance is provided?

- Up to \$750/month per household in state-funded rental assistance;
- Plus up to an additional \$750/month per household in Allegheny County-funded rental assistance
- Up to \$200/month per household in County funding to cover utility arrears
- Maximum 6 months

Applications to Date

- Total # of applications received
 - 5,536 tenants (unduplicated)
 - 2,791 landlords
- Most applications were sent in without any supporting documentation
 - Reaching out to these applicants to help them collect the needed docs
 - Wrong phone numbers/No voice mail/No answers
 - Don't live in Allegheny County
 - No longer need support
- Most applications did not have accompanying Landlord application
 - Reaching out to landlords to get the needed documentation
 - Refuse to participate or sign anything
 - Refuse to send their W9 (needed for payment)

Additional Challenges

- Very fast start-up with unclear (and changing) guidelines
 - Had to build support infrastructure while running program
- Small window for applying (July 6 – Sept 30)
- Requires extensive documentation in addition to online application
- Requires both a Tenant and Landlord application
- Arrears must be caused by COVID.
 - E.g. People on fixed income or those who were unemployed or behind on rent prior to the start of pandemic (March 2020) are not eligible

Progress to Date (continued)

Total # of applications paid as of this morning

109 CRRP program

+

81 new county-only addendum program (started September 14)

TOTAL = 190

- We have added a county-funded process for applicants that meet the CRRP eligibility standards but couldn't meet all of the documentation standards.
 - ✓ Accepts proof of Pandemic Unemployment
 - ✓ Does not require the Landlord full application
 - ✓ More flexible documentation standards
- The State recently lowered the documentation requirements for CRRP and we are hopeful that they may increase the time to apply into October.

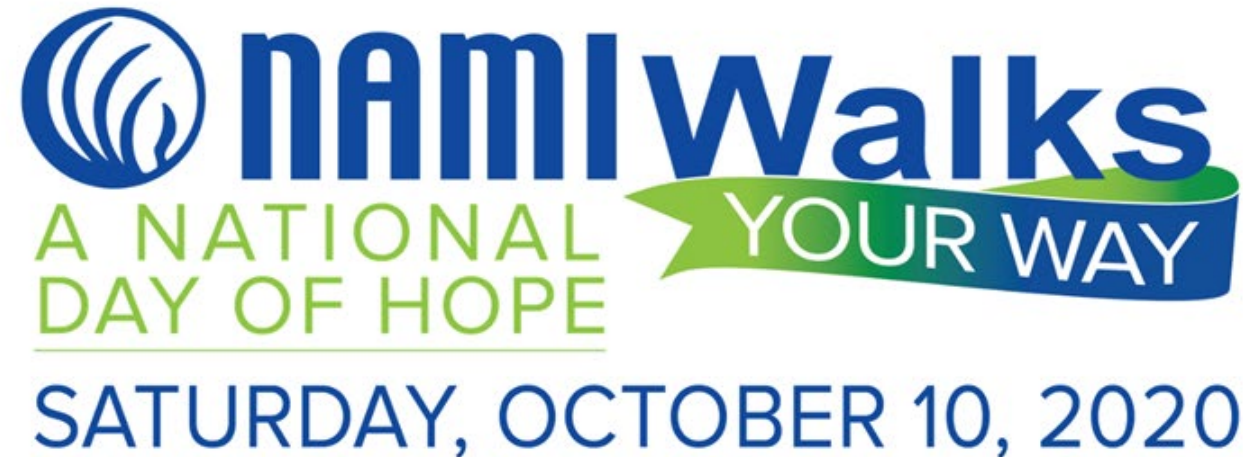

1. Validate their feelings




Validation sounds like...

“That makes sense.”

“That sounds difficult.”

“I’m sorry you are struggling right now.”

2. Appreciate their courage



Thank you so much for talking to me. That took a lot of courage.

Speaking up or sharing can be hard. Show you're there to support them.


Affirmation sounds like...

“Thank you for sharing.”

“You are not alone.”

“I'm here for you.”

3. Refer them to skills and support



*I think it might be helpful
to talk to someone.
I can stay with you while
we call/text a hotline.*

Support them by saying things like...

“Could we schedule a video chat and walk so we can see each other while we get some fresh air?”

Share tips by saying things like...

“I’ve been using this meditation app while stuck at home. Does that sound like something that might be helpful for you right now?”

Ready for change

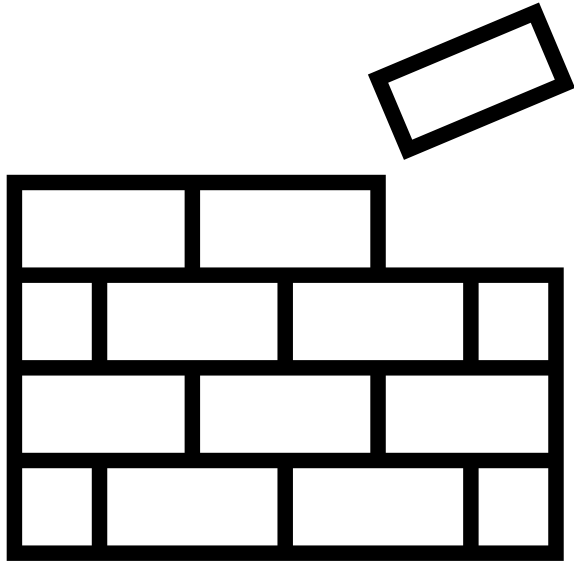
CYF is **building on the success** of its existing services and working with provider partners to **implement** new strategies that will improve the safety, permanency, and well-being of children in Allegheny County.

Why focus on foster care?

- Need more homes
- High turnover in non-kin homes



Laid the groundwork



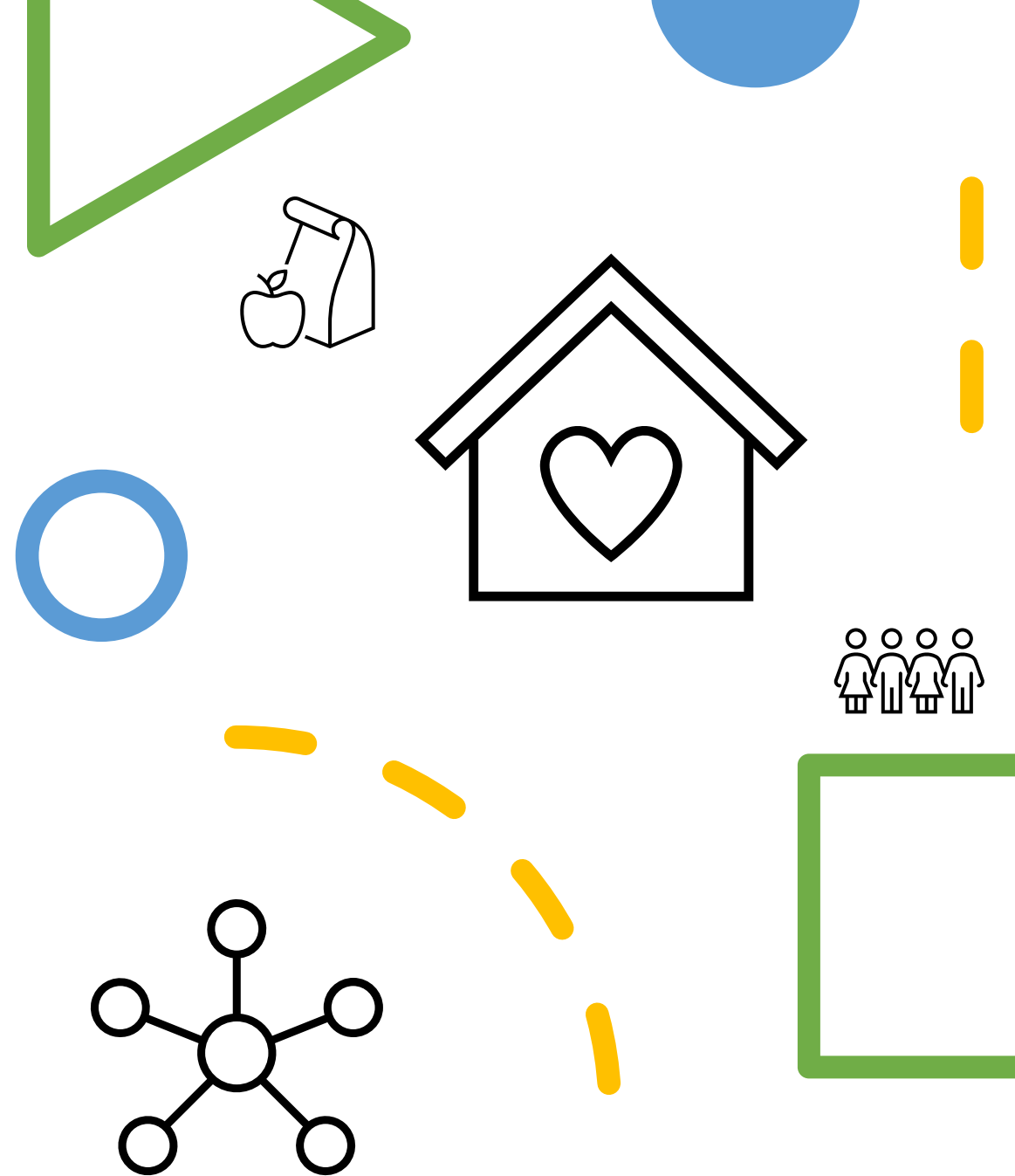
DHS/CYF and the 20+ foster care provider agencies in Allegheny County have made big strides in improving outcomes for children in the foster care system over the years, laying a strong foundation for the exciting changes to come.

- ~\$12 million annually supports foster care placements
- Increased number of children who exit to permanency
- Enhanced prevention (to reduce out-of-home placement)
- Increased number of children placed with kin while in out-of-home placement

The vision...

- Targeted **recruitment**
 - Diverse array of available homes
 - Enable children to stay in their neighborhood
 - Allow siblings to stay together
- Loving homes with foster care families who practice **cultural humility and cultivate relationships with birth families**
- A **network of peer support** for foster care families, that includes foster care parents who live nearby and can provide advice, resources and respite care when needed
- Aftercare for children

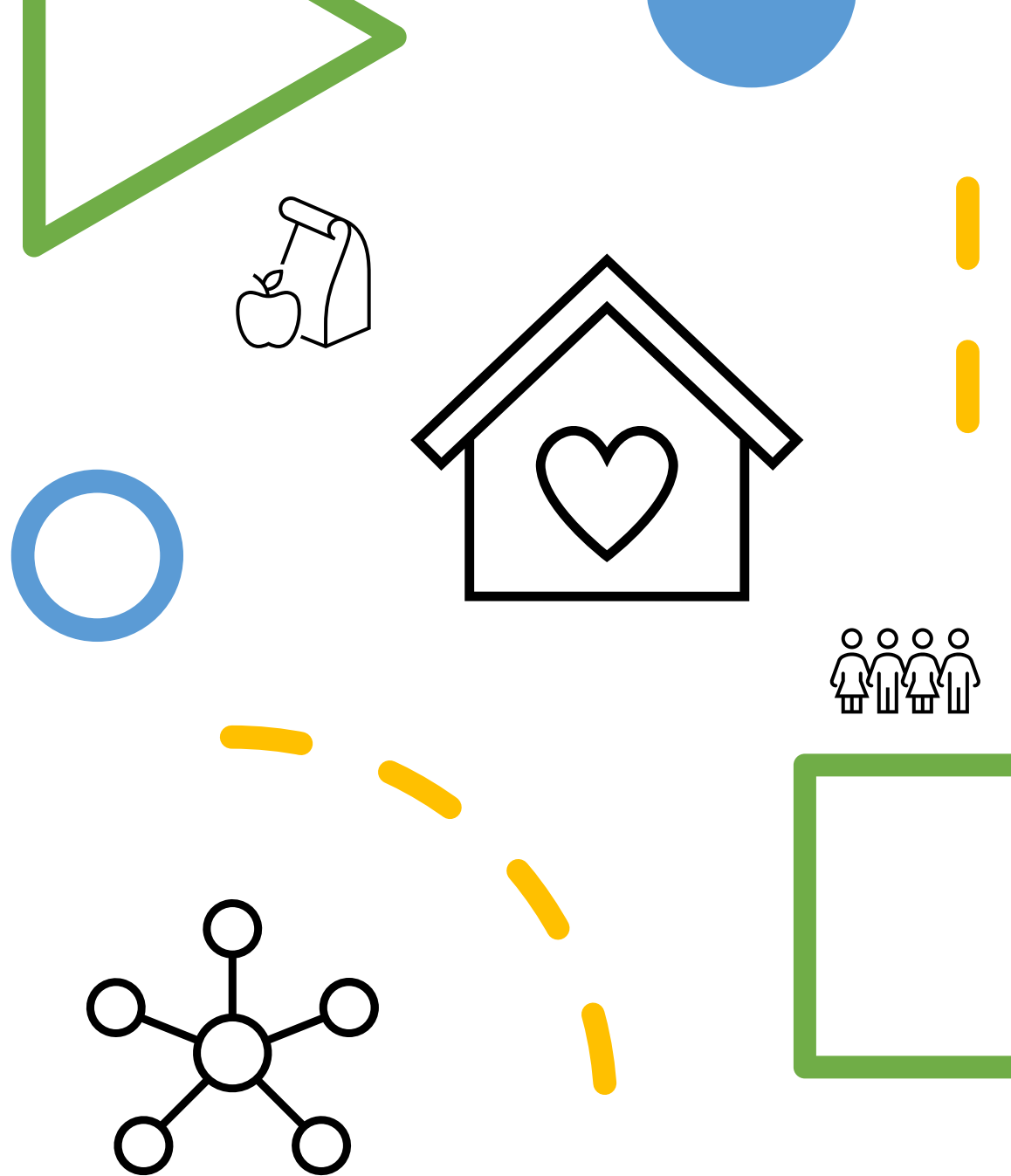

The vision...

- Providers and foster homes are **fairly reimbursed and have resources they need** to ensure a successful placement and aftercare services
- Within each region, some of the homes are **therapeutic foster care homes** and every foster care home is trained in **trauma-informed care**
- Stronger **partnerships** between CYF and provider agencies

...to ultimately improve outcomes for children in our care.



How is this different?

- Robust and targeted foster parent recruitment and retention efforts to ensure an adequate number of placement options at any given time to ensure first placement is the best placement
 - Geographically and demographically focused, to improve education and placement stability
 - Enhanced support and training for foster care families (peer support, trauma informed training for all homes, etc.)
 - Aftercare supports to sustain reunification and permanency
 - Improved communication and collaboration between CYF and providers (i.e. data sharing, clear rate setting process, accountability)

What we're doing

Focusing on non-kinship family foster care

- Analyzed data and current system to understand biggest challenges
 - Released the [Foster Care Concept Paper](#) in July with our vision and ideas
 - Received 20+ comments on the Concept Paper
 - Reviewing and incorporating feedback into an RFP—where we “re-procure” **provider agencies**
 - Winter 2020 release
-

Foster Care Concept Paper Feedback

- Received 22 Comments
- **Some themes that arose in comments (not an exhaustive list of feedback received):**
 - Accountability measures should be tied to incentives
 - Need to recognize some things are out of providers' control; CYF and other players (e.g. Courts) should make relevant changes that support providers' work
 - More access to County data and less duplicative data entry for providers
 - Concerns about CYF lack of communication and support of providers and foster parents
 - Need to reassess the language used about the expectation for foster & birth family communication within 24-hour timeframe
 - Concerns about the "one size fits all" model for family support (Mockingbird Model) - suggestions to explore other models and current provider practice
 - Concerns about an expedited certification process

Election Poll Workers Needed

- Allegheny County continues to recruit poll workers for the November 3rd election. Poll workers will be provided with "infection prevention kits" for election day that includes a face shield, mask, gloves, disinfectant wipes, and hand sanitizer.
- Serve as a Judge, Inspector or Clerk of Election. Election Officers/poll workers earn from \$115 to \$140 for the day. New Election Officers receive paid training. County website [link](#) for more information.

Court update

- President Judge Clark issued a [court order](#) clarifying implementation of the CDC order to temporarily halt certain evictions nationwide (Sept 4 – Dec 31).
- The court order includes applicable procedures for instances when the CDC order does not apply, and procedures for when it does.
- In general, the CDC order requires a tenant to submit a CDC Declaration form:
 - Proof from residents that they are using best efforts to obtain government assistance, pay rent to best of ability, and have endured substantial financial loss.
 - CDC Declaration Form can be found here: <https://www.cdc.gov/coronavirus/2019-ncov/covid-eviction-declaration.html>.
- The [CDC order](#) contains detailed information about who is considered a “covered person” under the order.
