





Policy & Legislative Update - Federal & State

- President Biden signed 17 executive orders on his first day in office yesterday, including one
 instructing the CDC to immediately extend the federal eviction moratorium through the end
 of March.
 - Biden has committed to working with Congress to extend the moratorium further through September.
- PA Department of Health Secretary Rachel Levine was chosen by President Biden to serve as Assistant Secretary of Health for the US Department of Health and Human Services.
 - Gov Wolf will announce a replacement in the coming days.
- In a <u>report</u> released this morning, PA's Independent Fiscal Office (IFO) increased their estimate of the COVID-19 related state budget deficit to \$2b.
 - Without additional federal stimulus, either tax increases, spending cuts, or borrowing will be a part of the budget negotiations before Fiscal Year 2021-2022 starts on July 1.
- The County Commissioners Association of PA (CCAP) <u>released</u> their top 5 legislative priorities for the General Assembly: election reform, the expansion of broadband access, solutions to the emergency medical services crisis, protecting funding for county human services and increasing funding for community-based mental health services.

Policy & Legislative Update - Local

- Local PA State Representative Ed Gainey announced he is running for Mayor of Pittsburgh
 - Current Mayor Bill Peduto announced last week he is seeking a third term this year
- On Tuesday, Pittsburgh City Council members Ricky Burgess and R. Daniel Lavelle introduced an ordinance that would ban police from serving "no-knock" warrants in Pittsburgh.
 - A "no knock" warrant was utilized in the shooting death of Breonna Taylor last year in Kentucky.
 - Currently, no knock warrants are not utilized in Pittsburgh and are illegal in Pennsylvania, but the legislation seeks to ban them from any future use.
 - The Alliance for Police Accountability in Pittsburgh has also worked toward implementing this ordinance through a referendum.

Recent Federal Stimulus -- Key Supports for Individuals

Economic Impact Payments

- One-time \$600 payments to individuals (full payment for AGI up to \$75k, reduced amount until \$87k). \$600 for dependents. Most eligible people will get payments automatically; other eligible individuals will need to file 2020 tax returns
- For more information: IRS <u>FAQ</u> and <u>check payment status</u>

Emergency Rental Assistance Program

- \$25 billion nationwide to assist households that are unable to pay rent and utilities due to the COVID-19 pandemic
- Allegheny County Rental Assistance website for updates: https://covidrentrelief.alleghenycounty.us/

SNAP benefit increase and easier access for college students (information from USDA)

- Provides a 15% increase in SNAP benefits for 6 months (January 1 June 30, 2021) for all SNAP participants
- Temporarily waives strict work and eligibility requirements for college students who are eligible for federal or state-funded work study programs during the regular school year, or have no expected family contribution
- For more information: SNAP eligibility information from USDA

Flexibility to leverage Earned Income Tax Credit (EITC) and Child Tax Credit (CTC)

• Temporary ability for individuals to use earned income level from 2019 on 2020 tax returns to help workers who experienced lower wages in 2020 get a larger refund, consistent with the amount during a normal year

Pell Grant

- Increase of the maximum award by \$150
- Reinstates eligibility for students who are incarcerated

UPDATED COVID-19 DATA MOVES PPS BOARD TO CONSIDER POSTPONING IN-PERSON LEARNING TO APRIL 2021

- Board is considering halting the return to in-person hybrid learning and would postpone the phased-in approach until after Spring Break, April 6, following the anticipated rollout of the COVID-19 vaccine to employees. The Board will vote on the resolution at its January 27 Legislative Meeting next week.
- To support the return to in-person learning for all students, Allegheny County Health Department, UPMC, and UPMC Children's Hospital of Pittsburgh are working with the District to develop a plan to serve all staff and school district bus drivers desiring vaccination. Staff received an interest survey this week.


COVID-19 Early Warning Monitoring System Dashboard






PA state's early warning system dashboard



The 3-day average of total net hospitalizations has fallen since 12/17 (859). It was 368 on 1/21.




Deaths have risen since mid-November to a high of 21 (3 day rolling average) on 12/24. Deaths have fallen since then.

 - This is 4% of Allegheny County's population





Vaccine Provider locations

- The Department of Health recently released a map of vaccine providers that can administer a COVID-19 vaccine to anyone covered by Phase 1A.
- Anyone covered under Phase 1A that has not yet received a COVID-19 vaccine can contact any of these providers to check availability and schedule their vaccination, but we encourage providers to contact sites and coordinate for their employees who are eligible.
- Employees should be prepared to show proof of employment.
- This map is being updated regularly, so please keep checking for new locations with vaccine supply and available appointments.



DHS Guidance to Providers on Employee Vaccination

 DHS encourages providers to make a plan for communicating to employees the critical importance of getting vaccinated.



Providers' communications to employees re: vaccines

We suggest that providers' Covid-19 vaccine communication efforts to employees <u>incorporate</u> several considerations:

- 1) Frontline essential service workers' **early priority** to get vaccinated per the state and CDC guidance
- 2) A protocol that employees can follow to request an excuse from missed worktime that might be reasonably needed to get vaccinated;
- 3) The **benefits of getting vaccinated**, per <u>relevant CDC</u> guidance

Providers' communications to employees re: vaccines

- 4) Resources for learning about the safety of Covid-19 vaccines;
- 5) Contact information to Allegheny County Health Department's resource for providing up-to-date information about vaccination in Allegheny County (https://www.alleghenycounty.us/Health-Department/Resources/COVID-19/COVID-19-Vaccine-Information.aspx).
- 6) Messaging about the importance of wearing masks and social distancing even after employees get vaccinated.

DHS Guidance to Providers on Employee Vaccination – mandatory policies

- DHS is <u>not</u> requiring providers to implement a mandatory employee vaccination policy.
- But recent EEOC guidance does address this
- Our <u>DHS provider vaccination guidance</u> summarizes EEOC's position regarding mandatory employee vaccination policies.

Employers' mandatory vaccination policies are allowable – with caveats

- In Dec 2019, EEOC published guidance stating that employers <u>have</u> the auth to mandate vaccination among employees
 - This authority aligns with the portion of the ADA that allows an employer to require that an individual shall not pose a direct threat to the health or safety of individuals in the workplace.
 - In re to Covid-19, the EEOC said that public health authorities' finding of significant community spread supports the idea that unvaccinated employees do pose a direct threat to workplace safety.
- Employers have the authority to request documentation of vaccination - to track vaccination prevalence in their workplace (but may not ask for any medical information)

Mandatory policies – required exemptions

- Employers must allow exemptions to employees who cannot get vaccinated due to a disability, a contraindication, or a sincerely held religious belief
- Generally, employers may not terminate employees that cannot get vaccinated
 - Must find a reasonable accommodation that mitigates the health risk of the unvaccinated employee

DHS Vaccine Guidance – Summary of Topline

- In our view, providers in the greater DHS network can play a pivotal role in supporting high vaccination rates among our frontline essential workforce
- Providers are strongly encouraged to develop a communications plan and to affirmatively message to employees the importance of getting vaccinated
- We're in the early days of this effort
 - We expect to provide additional vaccination resources and information as we go
 - We are interested in creating virtual meeting spaces for provider staff to engage and interact in person with experts who can talk about Covid-19 vaccines and the benefits of them

HEALTH OF THE HOMELESSNESS SYSTEM

- Providers are still operating, sheltering, taking in new clients.
- Harder to find landlords and units available to our folks, we do have have access to Section & and Self-Pay SRO units downtown. If interested, contact Housing Navigator Unit at housingnavigators@alleghenycounty.us.
- Hearing that briefings are happening, not seeing new Section 8 vouchers or habitability inspections yet.
- Adult shelter beds available at some year-round shelters (EECM & Bethlehem Haven). CALL AHEAD BEFORE SENDING ANYONE.
- Beds filling up most nights at Smithfield and McKeesport winter shelters. People can still come, overflow sent to Safe Haven.
- Shepherd's Heart winter shelter (females) usually has open beds.
- Youth shelter beds available at DOCS.
- Several family shelter units available for families of all sizes.
- 2 Warming Centers open during hours winter shelters are closed. Open centers are at Red Door downtown and McKeesport Downtown Housing. The 3rd warming center, located at Catholic Charities on 9th & Liberty, will be open again beginning Saturday.
- Isolation and Quarantine facilities
 - (Safe Haven & Family) receiving referrals, taking in record numbers of people including increased percentage of positive/exposed.
 - Family I&Q space available.

MORTGAGE ASSISTANCE FOR CITY OF PITTSBURGH RESIDENTS

Mortgage assistance can be up to a total of \$6,000 (mortgage payments and utility assistance).

Homeowners can have income up to 80% AMI.

Housing Stabilization Program

If you live in the City of Pittsburgh and are in need of rental, utility, or mortgage assistance, contact United Way of Southwestern Pennsylvania 2-1-1 for more information on the Housing Stabilization Program.

The Housing Stabilization Program (HSP) is a housing crisis intervention program that provides one-time or short term financial assistance to households who are facing a temporary, non-recurring housing crisis.

One-time funding support includes:

- 1) Move-in assistance which may include:
 - First month's rent
 - Last month's rent
 - Security deposit
 - Utility deposits
- 2) Utilities in arrears
- 3) Rent in arrears
- 4) Mortgage payment (must not have an Act 91 notice)
- 5) Legal fees

Short-term funding support includes:

- 1) Rent subsidy, not to exceed three (3) months
- 2) Mortgage assistance, not to exceed six (6) months
- 3) Legal services throughout the eviction process
- 4) Legal fees related to court

To see if you are eligible for the program, please contact United Way 211. Contact information is on the back of the flyer.

Eligibility Requirements:

- Must be a renter or homeowner
- . Must live in the City of Pittsburgh
- Renters must be at or below 50% AMI
- Homeowners must be at or below 80% AMI*
- Must develop a stability plan with a service provider


