

COVID-19 DHS Provider Meeting May 21, 2020

General Information

As of the time of this meeting (5-21-2020 at 4:30 pm) there are 1,718 confirmed cases and 144 deaths in the County.

Local Grantmaking

At the last two meeting, we have had have funders join the calls to share their investments to date and future plans. Today we were joined by representatives from BNY Mellon Foundation, Hillman Family Foundations and Staunton Farm Foundation. Kenya Boswell, BNY Mellon Foundation of Southwestern PA

- Focus to Date
 - BNY Mellon invests through our foundation, corporate sponsorships and employee matching.
 - During COVID-19, they established avenues for employees to give directly through a 2-for-1 matching gift campaign. BNY Mellon matched at a rate of \$2 for every \$1 given by an employee.
 - They first reached out to existing grantees to inform them of flexibility with their current grant funds.
 - They focused on critical and basic needs.
- Future Plans
 - Focus on workforce development, specifically getting individuals back in the workforce.
 - Thet are discussing possibly increasing giving levels above their mandated 5%.

Lauri Fink, Hillman Family Foundations

- Focus to Date
 - Focused on Basic Needs at a systems level, including Allegheny County DHS.
 - \$5.3M of giving so far during COVID-19
 - Global Links was their primary grantee for critical supplies.
 - They extended flexibility to existing grantees.
- Future
 - They are continuing to focus on COVID-19 response, basic needs, and those disproportionately affected by the crisis.
 - They are staying nimble as things unfold.

Joni Schwager, Staunton Farm Foundation

- Focus to Date
 - \$600,000 in emergency grants, half within Allegheny County.
 - They focused on telehealth and technology.
 - They are continuing to give emergency grants at this time.
- Future
 - They will continue this approach through the rest of the calendar year.
 - The board is committed to acting quickly.

Testing Sites Update. New testing sites include:

- Tests at 7 FQHC as partnership between ACHD and the RK Mellon Foundation
- Testing at 2 CVS locations with more sites this week
- These have all been added to the <u>testing site map</u>

All PA Licensed Residential Providers are requested to complete a survey by May 26th.

- The Wolf administration has developed and released a <u>Testing Strategy</u> that focuses on the three pillars, which include accessibility, availability and adaptability.
- The Department seeks to understand the testing environment in its residential facilities and requests that each facility complete this <u>testing survey</u> no later than Tuesday, May 26.

Legislative/Policy Updates

Federal Updates

- 5th Federal stimulus bill: Senate introduced bipartisan SMART Act as alternative to House HEROES Act, with a much narrower scope
 - \$500 billion in flexible funding for state and local governments to cover COVID response costs as well as some lost revenue

- Removes 500,000 population threshold, so any municipality qualifies
- Strictly for state and local government relief does not include any other funding from the \$3 trillion House HEROES Act

State and local updates

- PA House Republicans' attempt to override Gov. Wolf's veto of a bill that would have allowed broad business reopening across the State failed to garner two thirds majority.
 - Emphasis on reopening businesses quickly continues to overshadow state budget discussions at the State Capitol
- The Allegheny County Board of Elections is receiving pushback on a limited number of in-person polling locations for the June 2nd Primary.
 - The County received State approval to reduce the number of in-person locations due to COVID-19.
 - County pointing to large number of mail-in ballots received as proof that in-person turnout will be lower.

Food

As a reminder, here is the best way to support families/individuals with food access:

- 1. Encourage families/individuals to apply for public assistance.
 - a. SNAP
 - i. <u>Food Bank</u> and <u>Just Harvest</u> both offer support with applications.
 - ii. Pennsylvania was just approved for online SNAP purchasing coming soon!!
 - b. P-EBT
 - i. Up to \$370.50 per child for families enrolled in free/reduced lunch (and ALL PPS families)
 - ii. Remind families to make sure their updated address is on file with school district.
- 2. Support families/individuals in finding access to food
 - a. Pantries and other emergency food options:
 - i. Use this map or "Get Help" on the Food Bank website to identify pantries near household.
 - b. Grab and Go sites (for families with children):
 - i. Use <u>this map</u> or "Grab and Go" on <u>Food Bank website</u> to identify the closest Grab and Go location.
 - c. Large scale Food Bank distributions
 - d. Call 2-1-1 or Food Bank Concierge (412) 460-3663 ext. 655

 - Childcare provider guidelines were shared with providers last week.
 - School age summer camp guidelines are under development.
 - Funding to Support Childcare Providers
 - Over \$4M in CARES funding will be distributed to childcare providers via ELRCs.
 - Local foundation community also made a \$500,000 investment to support childcare.
