



**COVID-19 DHS Provider Meeting**  
**June 4, 2020**



## General Information

Beginning the week of June 15<sup>th</sup>, we will only hold DHS Provider Meetings once per week on Thursdays.

- We will still have a meeting this coming Monday, June 8<sup>th</sup>.

Today we're joined by Carolyn Bebb, from the DHS's Free Tax Preparation Program.

- Traditional in-person tax services were suspended in March at DHS.
- The IRS has extended the deadline for filing 2019 tax returns until July 15<sup>th</sup>.
- Virtual tax prep appointments are available between May 26<sup>th</sup> and June 30<sup>th</sup> on Monday, Tuesday and Thursday evenings. *Alternate hours may be provided upon request.*
- To participate:
  - Most individuals who made less than \$30,000 and families (more than one person) that made less than \$55,000 in 2019 are eligible for the program.
  - Taxpayers must have all tax documents, valid ID and social security cards, and date of birth for all individuals on the tax return. Direct deposit information is also recommended to expedite refund.

### COVID-19 Metrics

Allegheny County is below the following benchmarks:

- Diagnostic testing capacity

Allegheny County is almost meeting the following benchmarks:

- Decline in new cases: we have seen some small increases over last three weeks, but overall number is still low.
- ICU bed capacity - Our bed capacity has been declining.

Allegheny County is meeting the following benchmarks:

- New cases below threshold: we have always been below the PA threshold over a rolling 14-day period. UPenn projects that new cases will continue to decline.
- Decline in total hospitalizations: we have seen declines in past two weeks
- Decline in Deaths: We have a low death rate and a decline in deaths.
- Increase or steady number of tests: we have seen an increase in the number PF tests administered over the last 4 weeks.
- Percent of Positive tests: our average positive rate is low and declining, around 3%.
- Rate of transmission below 1: we are at .91

## Legislative/Policy Updates

### Federal Updates

- Congress passed reforms to Paycheck Protection Program (PPP), Senate considering extending federal unemployment payments.
  - Bill heading to President allows PPP funds to be spent over 24 weeks instead of the original 8 weeks and still be forgiven, and changes a 75-25 divide — which required businesses to spend 75 percent of the loan on payroll and 25 percent on other fixed costs such as rent and utilities — to a 60-40 ratio, allowing more flexibility for fixed costs.
  - Due to growing unemployment, conversations are beginning among Senate Republicans about what to do about federal unemployment aid after the July 31 expiration; one proposal is to extend the period but lower the amount from \$650 to \$450 a week.

### State and Local Updates

- Based on May revenue decreases, PA Department of Revenue announces losses to current Fiscal Year 2019-2020 General Fund are around \$2.6 billion.
- Allegheny County Board of Elections reports turnout for Tuesday's Primary at 40%, almost double over what has been normal for a second term presidential election year.
- Mayor Peduto calls for independent investigation into police action in breakup of peaceful protest in East Liberty earlier this week.

## Food

There is a Food Distribution scheduled in Natrona Heights tomorrow, June 5<sup>th</sup> from 1-3 pm at the Highlands High School Gym.

Our Out-of-School-Time providers have been closed during this period but served over 20,000 grab and go meals in May! See slide presentation for pictures.

  - As a reminder, eviction cases that were pending in March have resumed. We expect ~400 pending eviction cases. And the eviction moratorium expires July 11, so new eviction cases can be filed then.
    - For rental assistance and eviction prevention assistance, contact the Allegheny Link (1-866-730-2368).
      - Rental assistance (first month's rent and security deposit) is available to people who are in shelter or street homeless.
      - Eviction prevention: person must have a judgement from a magistrate
