The Port Authority is launching online public meetings for NEXTransit. This is the first series of public and community meetings to gather input on the future of public transit in the Pittsburgh area. COVID-19 Guidance Update

As a reminder, on July 17th, ACHD announced new guidance that takes state level guidance into account and remains in effect until revoked.

- Indoor and outdoor dining/alcohol consumption must end by 11 PM. Take-out and delivery for food/alcohol can continue after 11 PM. (State guidance makes it clear the number of indoor diners cannot exceed 25% of the fire code maximum.)
- Events/gatherings limited to 25 people indoors/50 people outdoors. (State guidance allows 250 outdoors, but ACHD kept a lower limit.)

COVID-19 Metrics

Allegheny County is not meeting the following benchmarks:

- Decline in new cases: 816 new cases the week of 7/19; although this is a decline, this remains high.
- New cases below threshold: our rate is 279 per 100,000 residents, still above 50, but decreased by 16% over the last week.
- Diagnostic testing capacity: Our tests to cases ratio is at 13:1, well below the recommendation of 50.
- New cases below threshold: We are now above the PA threshold of 50, at 209.
- Decline in hospitalizations: We have seen an increase in hospitalizations with 167 people hospitalized over the past 14 days.

Allegheny County is meeting the following benchmarks:

- Decline in deaths: There were 10 deaths the week of 7/19. Total deaths did increase in July but have decreased over the last week.
- Rate of transmission below 1: 0.91 during the week of 7/22

- Percent of positive tests: It is now 7.9% and has been decreasing for the last two weeks.
- ICU bed availability: About 17% of ICU beds are available.

DHS Procurement Manager Kelly Prokop joined the call to talk about Cleaning Services for Congregate Care Providers.

- DHS has entered into a contract with ServiceMaster and set up a process for DHS-contracted congregate providers and DHS staff to request cleaning services after a known COVID-19 incident.
- Congregate providers can [request services through this form](#) after someone who meets the following criteria was present in the building:
 - Person has a confirmed positive case of COVID-19
 - Person has been exposed to COVID-19 AND is showing symptoms

Legislative/Policy Updates

Federal Updates

- U.S. Senate has unveiled a \$1 trillion relief package, formalizing the starting point of negotiations for the next bill.
 - We'll continue to track and report on details of the negotiations.

State and Local Updates

- Based on Pittsburgh City Council action, the City Code will now include language on policing that bans chokeholds and neck restraints and requires officers to intervene if they see “unreasonable force.”

Court Updates

- On July 28th, Judge Clark announced that the courthouse will remain open with more efforts to conduct court activities through teleconferencing.
 - As of now, teleconferencing will be utilized for bail hearings and motions, guilty pleas, sentencing hearings and ARD hearings.
 - Non-jury trials can take place via videoconferencing if the defendant agrees to it.
