As a reminder, the **deadline for the 2020 Census** is September 30th.

- The city and the county are undercounted compared to 2010 levels. The East End and Mon Valley are particularly undercounted right now.
- Please do whatever you can to get the word out, and let DHS know how we can help.

The County announced a [new COVID-19 Testing Site](#) in McKeesport at 455 Industry Road, opening on 9/15 at 10 am.

Molly Morrill and LaTrenda Sherrill joined the call to talk about Allegheny County's Safety and Justice Project. We have been participating in this project for the past few years and now have the opportunity to apply for additional funding to extend the project.

- We are being asked to propose a project that reduces the Jail population levels and reduces racial and ethnic disparities within the justice system.
- We are partnering with DHS, the courts, District Attorney's office, pretrial services and probation
- Our proposed strategies prevent people from getting involved in the criminal justice system and reduce the amount of time spent in jail. They include:

- Crisis Response
- Early Representation
- Pretrial Assessment
- Expedited Court Processing
- Reduce the Number and Length of Detainers
- Jail Redesign
- Community Engagement
- Racial Equity
- We want feedback from the community on these strategies, please answer the questions on [Neighborland](#) and share the link with others. Questions include:
 - What are some ways Allegheny County can continue to reduce its jail population?
 - How should Allegheny County support community-based efforts to improve public safety?
 - If you or a family member were involved in the criminal justice system, what do you wish had happened differently?

Supply Availability

We are continuing our partnership with Global Links to get supplies to the provider network.

- We have reserved \$1M of CARES funding for another round of supply distribution. You can access these supplies at no cost, starting today (9/10) through [this form](#).
- There is a finite quantity so please only request what you need.
- DHS providers can select from a special menu of supplies including emergency facemasks, full face shield, non-contact infrared thermometers, hand sanitizer, Clorox clean-up disinfectant, and limited supplies of baby, and incontinence & personal care items.

COVID-19 Metrics

[PA has posted an early warning indicators dashboard](#). The data is updated every Friday.

- There was an increase in newly reported cases, incidence rate and resting positivity rate over the past week (August 28th-September 3rd).
- There was a 32% increase in new cases reported over the last week.
- There was a 34% increase in the incidence rate per 100,000 residents over the last week
- There was a 19% increase in positivity rate over the last week.

Legislative/Policy Updates

Federal Updates

- Chances for larger 5th Federal stimulus bill unlikely before October government-funding deadline.
 - A "skinny" Republican-backed stimulus bill was blocked today in the Senate.

State and Local Updates

- PA Senate Appropriations Committee on Wednesday advanced COVID-19 funding-related bills on a bipartisan basis:
 - \$150 million to assist residential and small business customers with utility payments.
 - \$200 million to create the Nonprofit Economic Emergency Delivery Systems Grants Program, a statewide competitive grant program to be run by the Commonwealth Financing Authority for eligible community-based, human service nonprofit organizations (e.g., childcare centers, domestic violence centers, food banks) impacted by the COVID-19 pandemic. Maximum grants will be \$500,000 per eligible nonprofit.
- PA Office of Unemployment Compensation has begun distributing the additional \$300/week through the [Lost Wages Assistance \(LWA\) Program](#).

- The additional payments are available for 6 weeks with eligibility based on unemployment (or partial unemployment) due to COVID-19, with other details and criteria available online.
- Unemployment Compensation recipients must complete a Certification to receive the additional funding and are advised to do so as soon as possible. Individuals currently receiving benefits thru the Pandemic Unemployment Assistance are automatically eligible and do not need to apply. Information on completing Certification [here](#).
- Pittsburgh's URA Board expected to approve small business rental assistance today.
 - Will provide up to \$333/month for a maximum of three months to help offset rent paid by small businesses with fewer than 30 employees in Community Development Block Grant-eligible neighborhoods.
 - The program will match any landlord rent reduction – for example, if the landlord drops the rent by \$200, URA will then give an additional \$200 to the small business.
 - URA earmarking \$40,000 for this program, with a max of \$1,000 per business.
- President Judge Clark issued a [court order](#) clarifying implementation of the [CDC order](#) to temporarily halt certain evictions nationwide (Sept 4 – Dec 31).
 - In general, the CDC order requires a tenant to submit a [CDC Declaration form](#)

Program Updates

OCS

- Allegheny County's Community Learning Hubs will serve as places for children to engage in virtual learning and participate in enrichment activities.
 - More hubs opened this week. We are so proud of our partners for making this happen!

 - There is still space available at many hubs!
- We are using CSBG Supplemental funds to provide one-time emergency assistance for individuals and families throughout the County (except for the City of Pittsburgh). Participating agencies include:

- Housing
 - We are following the Health Department guidance, which recommends quarantining individuals for two weeks who have arrived from a high-risk state (see slide presentation for a full list of states). Please reach out to your Safe Haven contact if you are lacking space for someone to quarantine.
 - The Census will be targeting people experiencing homelessness September 22-24.
 - Enumerators will be wearing bright orange vests and approaching people at locations within the community including shelters, soup kitchens and, possibly camps (if locations are known).
 - Please let clients know that this will be occurring.
 - The next Homeless Network provider call is on 9/15 at 9:30 am, focused on peer support and psychological rehabilitation services; please see slides for access information.
 - Also, “Ask a (Housing) Navigator! Office Hours” are being held every Tuesday from 10:30-11:00 am; please see slides for access information.
 - Housing navigation-focused provider trainings will begin in September, and landlord trainings are in the works.
