

## State COVID-19 Guidance Update

#### PA Dept of Health

- Order takes effect tomorrow (Friday, Nov 20th) Travelers visiting Pennsylvania from another state, or Pennsylvanians returning to the state, must get a negative COVID test within 72 hours before entering or re-entering the state, or otherwise quarantine for 14 days upon entry.
- People must wear a mask anytime outside the home. This includes in restaurants, retail stores, parks, gyms, public transportation and everywhere else indoors OR outdoors.
- People shall wear masks in any enclosed space, where another person or persons who are not members of the individual's household are present in the same space, irrespective of physical distance.

# Allegheny County Dept of Health Guidance

#### Residents are strongly encouraged to:

- Not have guests in their homes unless they are essential workers (e.g., home healthcare providers, childcare workers or educators)
- Cancel traditional Thanksgiving celebrations and celebrate virtually with non-household members
- Avoid unnecessary travel
- Limit social event gatherings

Social event gatherings mean any pair or group of individuals who reside in different households who are in close proximity of one another for more than several minutes who come together for non-business-related activities. Social event gatherings include, but are not limited to, celebrations, parties, dinners, barbeques, and the like.

# Policy & Legislative Update - State

- The General Assembly will most likely finalize the state's 2020-2021 budget by the end of today, which has a roughly \$2b gap due to COVID.
- While not final yet, it appears the state's budget deal will include the following means to close the funding gap, to what will be close to a flat fund budget:
  - \$1.3b CARES Act funding
  - \$340m from state's Rainy-Day Fund
  - Some targeted cuts (unclear where those will be)
  - Funds pulled from a couple state special funds

#### COVID-19 Interim Vaccination Plan V.2

- The state rolled out the COVID-19 Interim Vaccination Plan Version 2 today during a 12:15 pm press briefing
- The plan discusses the possible roll out of the vaccines and who will first receive the vaccines. Currently, there are potential phases for distribution. The phases have different options, especially due to the impact of COVID at the time. Healthcare workers/first responders/critical workers/people with high-risk conditions would receive the vaccine first (most likely)

#### COVID-19 Early Warning Monitoring System Dashboard









The average weekly positivity rate has been increasing for the last month and has been above 10% since November 3<sup>rd</sup>. On November 13<sup>th</sup>, there was a **17% positivity rate** (185 cases out of 1,072 tests). This is the highest positivity rate since Allegheny County really began testing people




Though the number of people tested has been increasing since early September, the number of cases has increased at a faster rate. As such, the number of people tested per new case has been falling since early October. The ratio is the lowest it has been during the pandemic. 795 people were tested on 10/10 (with 40 cases) compared to 1,072 on 11/13 (with 185 cases)




Cases have been rising throughout October. They have increased 213% (815 to 2,553) from the week of October 11<sup>th</sup> to the most recent week (November 7th).

- November 10<sup>th</sup> had the highest number of cases (confirmed or probable) in a single day since the start of the pandemic – 558 cases.




 Children's Hospital of Philadelphia (CHOP lab) projects weekly cases per 100,000 people to continue to rise (steeply) throughout November.





The case rate per 100,000 residents is at the highest rate since the beginning of the pandemic. On 11/13, there was a case rate of 337 cases per 100,000. Since the week of 10/17, we've seen a 134% increase in the case rate.




The 3-day average of total net hospitalizations has increased by 134% since 11/6 (from 140 to 328 on 11/18). Note: this is a lagging indicator and we would expect to continue to see increases in hospitalizations in the next few weeks (corresponding to continued increases in


cases)



ICU bed usage exceeded 90% for the first time since the start of the pandemic. It was 91% on 11/16




Deaths remain low and have been low throughout the pandemic, never exceeding daily deaths of 6 (3 day rolling average).



All 3 models that we are looking at (CHOP model, RTLive and COVID Act Now) have an estimated R above 1 throughout November and into December. This information shows the CHOP model results. They are projecting the R value to remain at about 1.4 (above 1) through

mid-December.

#### **Taking Our Pulse**

The goal of the Community Pulse Report is to keep track of a consistent set of indicators as a way of taking the pulse of our community during these difficult times and to further inform policy makers, nonprofit leaders, reporters, and the public in general. The report is organized into four sections:



Health & Wellness



Educational Disruptions & Child Care



Jobs & Financial Assistance



Food Access & Housing

Our aim is to utilize data that will give us a snapshot of what is happening in the five-county region—Allegheny, Armstrong, Butler, Fayette and Westmoreland Counties. Important to the project will be finding data that deepens our understanding of the intersecting disparities in health care, society, and the economy and their impacts on Black and LatinX children and families.



#### A Note on Disaggregated Data & Geographies

We are committed to utilizing data that can be disaggregated by race, gender, and age.

In future reports, we will strive to identify proxy indicators where disaggregated data is not available. We will also advocate for the disaggregation of data by race, gender and age and hope you can join us in that work.

**Utilities**: On slide 15 we highlight the growing backlog of customers unable to meet their utility obligations.

- Until late September, the Pennsylvania Public Utilities Commission had a moratorium on utility shut offs in place.
- National United Way 211 data suggests that utility needs this fall have started earlier and are greater than they were during the fall of 2019.
- Our own five-county region saw 211 utility assistance requests increase 31% from last month.
- With the end of the moratorium, winter approaching, and no support from the PA General Assembly or Congress, calls for utility assistance and payment plans will increase rapidly.





**Housing**: On slides 17 to 20, we highlight the growing need for housing support.

- An eviction and foreclosure moratorium put in place at the beginning of the pandemic initially protected many families from losing their homes.
- In October, Governor Wolf's moratorium ended and he <u>extended the application</u> <u>deadline</u> for the state's mortgage and rent relief assistance program, to boost participation by landlords and keep more people in their homes during the pandemic.
- At the same time, the <u>CDC issued a clarification</u> earlier this month that allows landlords to resume eviction proceedings, although <u>protections remain in place for certain households</u>.
- In July, 1 in 5 renters reported being behind on rent, and households of color reported far higher rates of missed payments compared to the national average. (Center for Budget and Policy Priorities, July)





**Decrease in Utilization of Health Care**: On slide 11, we highlight a recent Center for Medicare and Medicaid Services report pointing to the decreased utilization of health care services for children.

- Of significant concern are reduced numbers of screenings, vaccinations, and mental health visits.
- The rapid shift to telehealth is a bright spot and something we hope will continue, even beyond the pandemic.

Internet Access, Learning Models, & Telehealth: Access to high-speed internet remains a challenge for 20-25% of households in the region (slide 16).

- The explosion of telehealth services (slide 11) combined with the concentration of remote learning for low income children of color (slides 21-22) underscores a pressing need for internet access for our families.
- Internet connectivity must be treated as an essential utility -- like water, gas, and electric.





**Child Care**: The decline in child care (slides 23-24) is already impacting labor force participation and is expected to get worse.

- The share of women employed and at work is the lowest it has been in 35 years.
- Nationally, the percentage of mothers not in the labor force was 29.1% in September, up from 26.4% in September 2019.
- Workplace engagement for Black and LatinX mothers fell more than for White mothers, because of exits from the labor force at greater rates and also a larger increase in unemployment.

#### From the Field

Feedback and observations from our on-the-ground providers are critical to understanding the data we are collecting in context. This month, providers shared the following:

- Top needs continue to be housing and utility assistance.
  - With an upcoming end to the utility moratorium, concerns are that balances are quite large, and that water and sewer bills are not covered by utility assistance programs (LIHEAP, Dollar Energy, etc.).
  - Suggestions for action: extended moratorium, expanded unemployment, additional funding for utility assistance
- Access to internet is a concern as well.
  - Suggestions for action: additional funding for internet access, create a LIHEAP equivalent for internet access

"People are struggling to pay water and electric. Multiple people have had these services shut off."

"Not all families have access to technology or wifi for virtual supports. We imagine there is greater need than we know with families who do not know where to turn or how to reach out for help."






#### **Child Food Insecurity**








In the five-county region, the number of children living in food insecure households is predicted to increase an estimated 58% between 2018 and 2020.


#### COVID-19-Associated Hospitalization Rate

Nationally, Black and LatinX children have higher rates of COVID-19-associated hospitalizations than White children.

Existing disparities in the social determinants of health, as well as in access to and utilization of health services, could be responsible for these inequities. Other health disparities could be exacerbated by the decreased utilization of care referenced on the previous slides.








#### **Employment of Black Workers by Industry**



We are worried about what this lack of payment plans could mean: that people are neither paying, nor saving to pay—which will mean major balances and shut offs in the spring.










#### Learning Models, Start of the School Year






#### Learning Models, Start of the School Year






#### Gaps in Needed Child Care, Pre-COVID

# **Allegheny County Community Learning Hubs**

Safe places for kids to go to do schoolwork and participate in enrichment activities during COVID-19.

- 60 hubs currently open
- >1300 students are enrolled in hubs
- ~1000 students attending every day
- Almost 60% in PPS, but many districts represented
- Every hub reports some contact with schools
- Reinforcing health and safety measures now
- CARES funding expires December 30, 2020

## Childcare Access

- Childcare providers have been open throughout pandemic except when the state mandated them to close (March – May), and many also received waivers to remain open during that time
- School closures have put a burden on families who rely on school for childcare
- Childcare providers had to reduce capacity to allow for physical distancing
- There ARE still childcare seats available across STAR levels, neighborhoods, and age in Allegheny County (but this does not guarantee the right fit for a family's needs)
- There is, though, a waiting list of 360 for the childcare subsidy

# Childcare Provider Sustainability

- Most childcare providers rely on a mix of private pay and subsidy funding for revenue, and margins are already very slim
- The pandemic hit this sector hard mandated closures, reduced capacity, resistance to return to congregate settings
- To minimize revenue loss:
  - State continued to pay childcare subsidy based on February enrollment through August
  - Nearly \$20M of state CARES funding was distributed March August
  - \$3.1M in county CARES funding will be distributed by end of December
- The hope is that these efforts will minimize number of providers who permanently close their doors, but revenue losses will continue into 2021


