American Job Plans – Key components

- ***Overview: Over \$2 trillion proposed plan from the Administration focused on jobs and infrastructure***
- ***\$137 billion to modernize schools and early learning facilities***
 - Upgrade childcare facilities and increase their supply, while encouraging businesses to build childcare facilities at places of work through tax credits
 - Improve physical and technological infrastructure of community colleges
 - Upgrade and build new public schools
- ***\$100 billion for workforce development***
 - Establish a new Dislocated Workers Program and sector-based training to tackle long-term unemployment and underemployment
 - Target workforce development opportunities in underserved communities, including for evidence-based community violence prevention programs, and invest in job training for formerly incarcerated individuals and justice-involved youth
- ***\$20 billion for social infrastructure to support innovation and productivity***
 - Develop regional innovation hubs that leverage private investment to fuel technology development, link urban and rural economies, and create new businesses, supporting community-led redevelopment projects that spark new economic activity, provide services and amenities, build community wealth, and close gaps in access to the innovation economy for communities of color
- ***\$45 billion for clean drinking water***
 - Replace all lead pipes and service lines

American Job Plans – Key components

- ***\$213 billion for affordable housing***
 - Produce, preserve, and retrofit over two million affordable and sustainable places to live, including \$40 billion targeted to improve public housing system infrastructure
- ***\$400 billion for raising wages and benefits for home care workers***
 - Expand access to quality, affordable home- or community-based care for aging relatives and people with disabilities
 - Expand access to long-term care services under Medicaid
- ***\$100 billion for ensuring broadband access***
 - Build broadband infrastructure in unserved and underserved areas to reach 100 percent high-speed broadband coverage
 - Reduce the cost of broadband internet service and promote more widespread adoption
 - Promote transparency and competition, including by lifting barriers that prevent municipally-owned or affiliated providers from competing on an even playing field with private providers, and require internet providers to disclose their prices

Getting out the word on benefits of filing taxes

- **Filing taxes this year will ensure individuals get all of money they are eligible for now and in the future**
- The tax filing deadline is **May 17, 2021** (But, if a filer doesn't owe money, there is no penalty for filing late)
- Reasons to file taxes as soon as possible:
 - Determines if an individual is eligible for money (stimulus, CTC, EITC) and makes it easier to get money in the future
 - **If individuals don't usually file taxes because lack of earnings from work or receiving disability benefits**, may not have received stimulus payments.
 - **If job loss or income dropped in 2020**, should file taxes so the IRS has most recent income information.
 - **If children are living in a household in 2020**, may be eligible for another payment later in 2021.
 - If tax was withheld from unemployment received in 2020
 - is taxpayers who received unemployment in 2020 and had tax withheld from those payments should also file a tax return. As a result of the 3rd stimulus package, a portion of unemployment payments from 2020 are no longer taxable and could result in an increased tax refund.

Policy & Legislative Update – Federal & State

- **FEMA will soon provide financial assistance for funeral expenses when a death was attributed to COVID-19**
 - FEMA will accept applications starting on Monday, April 12th through a dedicated call center (844-684-6333). Assistance is limited to a maximum of \$9,000 per funeral

- **Yesterday, the Biden-Harris administration announced two sets of actions around reducing community violence:**
 - investments in community violence interventions, including by leveraging funding through 26 current programs ([White House Fact Sheet](#)); and
 - actions to address gun violence as a public health epidemic ([White House initial actions](#))

Policy & Legislative Update - State & Local

- **Pennsylvania schools will receive \$4.9 billion for Pre-K through 12 schools to "return students to classroom learning and equitably expand opportunity for students who need it most"**
 - This latest funding was made available by the American Rescue Plan – amounts by district are available [here](#).
- **The Port Authority seeks public comment on raising bus fares to \$2.75 and canceling transfer fees for prepaid Connect Card users.**
 - People who pay in cash would continue to pay \$2.75 every time they board, while ConnectCard users would have free transfers during a 3-hour window.
 - Public comment period will run through May 5, with meetings held virtually on Thursday, April 22; Friday, April 30; and Tuesday, May 4.

- **Fifth Judicial District posted amended emergency orders on remote and in-person hearings as well as guidance concerning the CDC eviction moratorium, in light of COVID-19.**

Policy & Legislative Update - Local

- **On Tuesday, Pittsburgh City Council voted unanimously to amend the city’s emergency eviction moratorium in an attempt to make the ordinance more enforceable in the face of litigation.**
 - Under the amendments, landlords who evict without “good cause” can receive a fine of up to \$1,000 or \$2,500 in cases where children are living in the household — a decrease from the \$10,000 fine approved in the original ordinance. The amendments also remove language prohibiting landlords from refusing to renew a lease agreement.
 - Council passed the moratorium on March 2 in an attempt to temporarily limit evictions within city limits. The Landlord Services Bureau filed suit against the ordinance immediately after passage, seeking an injunction against the moratorium. Litigation is ongoing and the courts will ultimately decide if it is enforceable.
- **City of Pittsburgh offering free pediatric first aid, CPR, and fire safety certifications for childcare providers.**
 - All-day training will be hosted by the Office of Equity, Bureau of EMS and Bureau of Fire in partnership with Trying Together and the local ELRC.
 - Trainings will be held on Saturday, April 10 at 10:00 a.m.
 - Registration is required and space is limited.
 - Childcare staff and early learning professionals who work or reside in the City of Pittsburgh are eligible to participate and can sign up [here](#).




METRIC DEFINITION: The 14 day count of new cases per 100,000 residents is below 50.




METRIC DEFINITION: Percent of ICU beds that are currently occupied is less than 90%

Nearly 30% of hospitalizations for COVID-19 ultimately require critical care. Regional health care systems should both maintain sufficient bed capacity for a potential resurgence in cases and have specific ICU bed capacity.

















A positivity rate below 10% indicates that enough testing is being done to find all the active infections. Identifying the active infections is essential for contact tracing and to stop the spread of the disease.

Testing should be responsive to the number of cases. As case counts increase, so should testing. As case counts decrease, so also should testing.




