Policy and Legislative Update





Congress enacted a \$1.5 trillion spending bill with new levels of funding for Federal government programs for the remainder of the current federal fiscal year (ending Sept 30) with overall increases.

Department of Health and Human Services - \$108.3 billion total, a 11.65% increase from last year

- Administration for Community Living (ACL) receiving \$2.3b total, a 2.6% increase
- Administration for Children and Families (ACF) receiving \$29.9b total of annual appropriations, a 17% increase
- Health Resources and Services Administration (HRSA) receiving \$8.9b total, a 18.8% increase
- Substance Abuse and Mental Health Services Administration (SAMHSA) receiving \$6.4b total, a 9% increase Notable increase: Community Mental Health Services Block Grant funded at \$857.6m, a 13.2% increase

<u>Department of Housing and Urban Development</u> - \$53.7 billion total, 8.05% increase from last year

- Community Development Block Grant funded at \$3.3b, a 4% decrease
- Homeless Assistance Grants funded at \$3.2b, a 7% increase
- Project-Based Rental Assistance funded at \$13.9b, a 3.5% increase
- Section 8 Housing Vouchers funded at \$27.4b, a 6.5% increase

Department of Labor - \$13.2 billion total, 5.20% increase from last year

• Employment and Training Administration receiving \$9.8b, a 4% increase, with a notable increase of 27% for Registered Apprenticeships, funded at \$235m

Federal Legislation – Notable Provisions



- \$10m for ACF/HHS to establish a diaper distribution pilot grant program for non-profit organizations.
- \$5m for grants that place **early childhood education experts** in pediatrician offices serving Medicaid and CHIP patients.
- Congress urges CDC to develop and implement national goals and a national strategy to improve adolescent mental well-being and advance equity.
- Congress encourages CMS to identify **Autism treatment and services** most beneficial to people with Autism and to review existing coverage policies for these services.
- Funding to **improve maternal health**, including grants for Medicaid providers to provide integrated services to pregnant and postpartum women.
- An additional \$30m for the recently created NIH initiative, **Implementing a Maternal Health and Pregnancy Outcomes Vision for Everyone (IMPROVE),** to improve maternal health outcomes and reduce disparities.
- Strengthening of the Violence Against Women Act with grant funding for state and local services.

Federal Legislation – Notable Provisions



- \$20m for HHS to expand research on the **impact of the pandemic on mental health**.
- Medicare telehealth service extension and expansion for five months once the COVID-19 public health emergency ends.
- \$12.5m for CDC's **firearm injury and mortality prevention research** to study underlying causes and evidence-based methods of prevention of injury, including crime prevention.
- Increased funding for CDC's suicide prevention work and direction to:
 - implement and evaluate an evidence-based **public health approach to suicide prevention** with attention to high-risk, vulnerable populations; and
 - expand and enhance its **emergency department surveillance** on suicidal behavior and nonfatal suicide-related outcomes to provide data on suicidal ideation and attempts, disaggregated by demographics, to inform community-based suicide prevention efforts.
- Funding for HHS' National Institute on Drug Abuse to continue trials to expeditiously develop an FDA-approved **medication for methamphetamine** addiction.
- \$3.8m for the **U.S. Interagency Council on Homelessness** which works to prevent and end homelessness.
- \$166m for NeighborhoodWorks to **expand affordable housing options and strengthen economic development**.

Federal Legislation – Notable Provisions



- Congress urges the Department of Education to work with HHS to **expand access to mental health services for children and adolescents**, including through school-based health centers, and work with regional research centers on positive behavioral interventions.
- Funding for SAMHSA's Project AWARE for **school-and campus-based mental health services and support**, with \$12.5m for grants to support efforts in high-crime, high-poverty areas, and \$7m to increase student access to evidence-based, culturally relevant, trauma support services and mental health care.
- \$5m for new Project Prevent awards to increase the capacity of school districts to **serve students exposed to community violence**.
- An additional \$45m for school-based mental health services professional demonstration grant program.
- \$1 billion in launch the **Advanced Research Projects Agency for Health (ARPA-H)** to accelerate the speed of scientific breakthroughs for diseases such as cancer, diabetes, ALS and Alzheimer's.
- \$2.5 million for a **White House conference on food, nutrition, hunger and health** in 2022 to develop a roadmap to end hunger and improve nutrition by 2030.
- Funding to increase the maximum **Pell Grant** award by \$400 in academic year 2022 2023.

Federal – "Community Project Funding"



This year's appropriation process brought back this member directed funding, also known as "earmarks."

Locally, Representatives Doyle and Lamb and Senator Casey were successful in getting the following projects funded (highlighting ones most relevant to human services):

- POWER: \$1.5m for facilities and equipment
- Literacy Pittsburgh: \$675k for workforce development program
- New Sun Rising: \$1m for workforce development centers & \$548k for Millvale EcoDistrict Clean Energy Initiative
- Goodwill of SWPA: \$525k for Northside Common Ministries Rehabilitation
- Greater Valley Community Services: \$1m for Braddock Community Builders
- Action Housing: \$2m for Flats on Forward
- Pittsburgh Community Services: \$250k community services and workforce development in the Hill District
- URA: \$2m for Avenues of Hope, Centre Ave Revitalization

Medicaid & CHIP Coverage



- During the COVID-19 Public Health Emergency (PHE), certain Medicaid and CHIP requirements were waived, preventing people from losing coverage during the pandemic. HealthChoices membership is over 20% higher today than in January 2020.
- The PHE is expected to end this spring or summer, triggering an "unwinding" that will require states to resume conducting MA and CHIP coverage renewals.
- We'll need everyone's partnership to support participants with completing their renewals!
- Key messages for participants:
 - 1) Update contact information Make sure COMPASS/CAO has current mailing address, phone number, email, or other contact information.
 - 2) Check your mail PA DHS will mail letters about Medicaid or CHIP coverage. This letter will let people know if they need to complete a renewal form to see if they still qualify.
 - 3) Complete your renewal form (if you get one) Fill out the form and return it right away to help avoid a gap in Medicaid or CHIP coverage.





- Pennsylvanians with an annual household income at or below 150% of the federal poverty level can enroll in health insurance through Pennie at any time.
 - Pennie has <u>added</u> this new qualifying life event for low-income Pennsylvanians.
 - Financial assistance is available.
 - About 90% of Pennie customers receive financial assistance that reduce monthly health insurance premiums.
 - 13% of Pennie customers have health insurance premiums of \$1/month.
 - Average financial assistance is \$500/month.
 - Pennsylvanians enrolling during 2022 can benefit from the increased subsidies provided by the American Rescue Plan.

State Updates

- House and Senate Budget hearings by the Appropriations Committees have concluded, leaving Budget negotiations to begin and continue into June.
 - Lawmakers have until June 30th, when the current fiscal year ends, to finalize the budget for next fiscal year, 2022-2023.
- The makeup of the General Assembly next year will be impacted by redistricting and this year's election cycle for US Senate and PA Governor.
 - 23 General Assembly members are not seeking re-election, while 13 are running for higher offices.
 - Allegheny County will elect two new House members even before 2023 with the special elections this spring to fill seats held by Pittsburgh Mayor Ed Gainey and his Chief of Staff, former State Representative Jake Wheatley.

- There are additional reasons to file taxes this year:
 - Expanded Child Tax Credit (CTC) and Earned Income Tax Credit (EITC)
 - Third stimulus payment for eligible taxpayers who didn't receive it in 2021
- Reminder for folks to file as soon as possible to claim these credits and before the **April 18th tax deadline!**
- Tax filing assistance is available through Just Harvest and the PA Department of Revenue.

Tax Resource Hub



- National organizations have launched an <u>Earned Income Tax</u> <u>Credit and Child Tax Credit</u> <u>Information and Resource Hub</u>
- Outreach toolkits are available to assist with efforts to raise awareness about these important tax credits.









Eligibility

- Most families, even those with little to no income, can receive the full amount.
- Single parents making less than \$112,500 or a married couple making less than \$150,000—and have children under age 18 who will live with you for more than half of 2021— are likely eligible for the full benefit.
- CTC is a cash benefit, not income. The CTC will NOT count as cash against other federal benefits (SNAP, Child Care, housing voucher).
- Anyone, including grandparents, who are legal guardians may be eligible for the Child Tax Credit cash benefit.
- File taxes to receive the full CTC
 - Families who received part of their Child Tax Credit as monthly payments in 2021 can get their remaining CTC and other cash benefits by filing a tax return by the April 18th deadline
 - If parents did not receive monthly Child Tax Credit payments, they can receive the full cash benefits by filing a tax return.

EITC cash benefits available too

• Filing taxes will mean many families who are eligible for the Child Tax Credit will also get cash through the Earned Income Tax Credit and/or any missed American Rescue Plan stimulus payments.

Where children are at risk of missing out on the expanded CTC

"Children at risk of missing the CTC" is defined on this map as children with a Social Security number who appeared on health insurance forms but not on tax returns in 2019 or 2020.

Covid-19 Local Innovations in Vaccine Equity in Pennsylvania Grant

The Wolf Administration and United Way of Pennsylvania launched the Local Innovations in Vaccine Equity in Pennsylvania project (LIVE PA) to administer \$4 million in mini-grants to local non-profit organizations and \$630,000 for faith-based organizations aimed to reduce vaccine hesitancy and ensuring an equitable vaccine distribution throughout the commonwealth. This money is available on a rolling basis until the end of June 2022.

Housing & Homeless Services

Quick overview of what the Homeless System in Allegheny County looks like today & a glimpse of what the future holds



Allegheny County Homeless System Capacity



Services range from homeless prevention (rental assistance) to street outreach and shelter services to permanent housing programs

System Bed Capacity*	Number of Year-Round Units
Emergency Shelter	388 units (547 beds) + 128 winter beds
Transitional/Bridge Housing	138 units
Rapid Rehousing	578 units
Permanent Supportive Housing	1428 units*

People Served



In 2021, approximately 8,400 persons were served system wide*

- Homeless prevention: 900 people
 - An additional ~13,000 households were served in Allegheny County's ERAP program in 2021
- Street Outreach: 500 people
- Shelter: 3,400 people
- Bridge/Transitional Housing: 240 people
- RRH & PSH: 3,600 people

Trends & Observations



Homelessness should be rare, brief and non-recurring.

Rare:

- Newly Homeless
 - The percentage of persons entering homelessness programs who are considered "newly homeless" (not served in homeless programs in previous 2 years) has been trending down, from 86% in 2019 to 84% in 2020 to 71% in 2021.

Brief:

- Length of time in shelters
 - The median length of time persons stayed in shelters decreased in 2021 to 37 days, down from 52 days in 2020, but still higher than 2019 (28 days).

Non-recurring:

- Exits to permanent and stable housing
 - 49% of people exiting shelter/bridge/RRH in 2021 exited to permanent and stable housing destinations, down from 56% in 2020 and 2019.
 - 98% of persons served in PSH programs in 2021 remained in the program or exited to permanent and stable housing destinations, up slightly from 87% in 2020 and 2019.
- Return to homelessness
 - The percentage of persons who exited homeless programs to permanent stable housing destinations and returned to the homeless system within 6 months was 10% in 2021, an increase from 6% in 2020 and 3% in 2019.



Allegheny County Emergency Rental Assistance Program (ERAP) Winding Down



One year milestone for ERAP

- More than 30,000 applications submitted to the program
- More than 15,000 households have received rent and/or utility assistance
- More than \$95 million disbursed in rent and utility payments



What are the Changes to Rent & Utility Assistance?



Stop forward utility payments starting March 31 to be able to pay more in rent

Other programs are available to fill this need for applicants who qualify

Back rent up to 15 months still paid as initial payment No new applications accepted after 3/31/22

No rental payments made for any months after May 31, 2022

This limits the number of forward rent applicants can receive

We will continue to process the backlog of applications for as long as funding lasts

Isolation & Quarantine for **COVID**



We partnered with CHS to open the Safe Haven Hotel in April 2020.

- It has been serving as the County's Isolation and Quarantine space ever since.
- It also provided space for highly vulnerable individuals to move out of congregate or unsheltered settings to avoid COVID.
- We had access to over 100 rooms.

Our journey with COVID is not over, but we're in a very different place now with vaccines, lower rates and fewer hospitalizations.

The Safe Haven is moving to a new location and downsizing.

Second Avenue Commons



All services will be aligned with the principles of the Commons which include dignity, personal control, safety and privacy, harm reduction, trauma informed care, and flexibility.

- **24/7 Access Shelter:** 95+ beds (with 40 additional overflow for winter) in group sleeping rooms with dedicated personal hygiene facilities, space for pets, and storage facilities. Smithfield Winter Shelter will no longer operate.
- Day Drop-in Center: These services and space will be available to shelter and SRO residents as well as individuals experiencing homelessness that do not reside in Second Avenue Commons. The Drop-in Center will create a warm, welcoming environment that encourages individuals to become more deeply connected to available supports and services. It will include:
 - Personal hygiene and laundry facilities;
 - Space to relax, have a snack, charge a phone, create community; and
 - Rooms to meet with trained outreach staff and other case management services.
- A Medical Clinic for physical and behavioral health services.
- **Single Room Occupancy (SRO) Apartments**: 43 units open to any low-income person (30 50% AMI). Will also be an option for individuals with PSH or vouchers.

Addressing Behavioral Health Needs in the Homeless System



Challenge

- Significant proportion of individuals in the homeless system have behavioral health needs.
- Individuals are often high utilizers of crisis services.
- Most homeless shelters lack competencies to address behavioral health crises or to connect individuals to mainstream services.
- BH services are often disrupted or discontinued due the specific barriers people experiencing houselessness face.

Planned Responses

- DHS is exploring ways to integrate the front door to Homeless and BH Housing programs so clients are referred to the best housing option for their needs.
- FQHC Community Health Workers (CHW) with BH training to partner with shelters.
 - O Northside Christian Health Center and Light of Life. One-year with private funds that support CHWs.
 - o Potential to expand through ACHD CHW funding.
- Shelter-based BH specialist (one-year pilot)
 - o Identify those already utilizing mainstream BH supports and ensure stable connection to services.
 - Engage Individuals who have had BH services within past year, understand why services stopped and support reengagement.
 - Engage individuals who are at risk of termination from shelter due to behavioral presentation by identifying strategies to support their time in shelter.

Sustainability

- Collaboration between homeless services, OBH and Community Care Behavioral Health (MCO) to expand BH specialists -- Acute Service Coordination (ASC) -- to be based in shelters.
 - ASC services would be eligible for Medicaid billing.
